2 ENTITLED "AN ACT TO PROVIDE FROM THE GENERAL FUND FOR THE  
3 EXPENSES OF THE EXECUTIVE, LEGISLATIVE AND JUDICIAL  
4 DEPARTMENTS OF THE COMMONWEALTH, THE PUBLIC DEBT AND FOR THE  
5 PUBLIC SCHOOLS FOR THE FISCAL YEAR JULY 1, 1995, TO JUNE 30,  
6 1996, FOR CERTAIN INSTITUTIONS AND ORGANIZATIONS, AND FOR THE  
7 PAYMENT OF BILLS INCURRED AND REMAINING UNPAID AT THE CLOSE  
8 OF THE FISCAL YEAR ENDING JUNE 30, 1995; TO PROVIDE  
9 APPROPRIATIONS FROM THE STATE LOTTERY FUND, THE ENERGY  
10 CONSERVATION AND ASSISTANCE FUND, THE HAZARDOUS MATERIAL  
11 RESPONSE FUND, THE STATE STORES FUND, THE MILK MARKETING  
12 FUND, THE HOME INVESTMENT TRUST FUND, THE EMERGENCY MEDICAL  
13 SERVICES OPERATING FUND, THE BEN FRANKLIN/IRC PARTNERSHIP  
14 FUND, THE TUITION PAYMENT FUND AND THE BANKING DEPARTMENT  
15 FUND TO THE EXECUTIVE DEPARTMENT; TO PROVIDE APPROPRIATIONS  
16 FROM THE RESTRICTED REVENUE ACCOUNT WITHIN THE GENERAL FUND  
17 TO THE PENNSYLVANIA PUBLIC UTILITY COMMISSION; TO PROVIDE  
18 APPROPRIATIONS FROM THE JUDICIAL COMPUTER SYSTEM AUGMENTATION  
19 ACCOUNT TO THE JUDICIAL DEPARTMENT; TO PROVIDE APPROPRIATIONS  
20 FROM THE MOTOR LICENSE FUND FOR THE FISCAL YEAR JULY 1, 1995,  
21 TO JUNE 30, 1996, FOR THE PROPER OPERATION OF THE SEVERAL  
22 DEPARTMENTS OF THE COMMONWEALTH AND THE PENNSYLVANIA STATE  
23 POLICE AUTHORIZED TO SPEND MOTOR LICENSE FUND MONEYS; TO  
24 PROVIDE FOR THE APPROPRIATION OF FEDERAL FUNDS TO THE  
25 EXECUTIVE AND JUDICIAL DEPARTMENTS OF THE COMMONWEALTH AND  
26 FOR THE ESTABLISHMENT OF RESTRICTED RECEIPT ACCOUNTS FOR THE  
27 FISCAL YEAR JULY 1, 1995, TO JUNE 30, 1996, AND FOR THE  
28 PAYMENT OF BILLS REMAINING UNPAID AT THE CLOSE OF THE FISCAL  
29 YEAR ENDING JUNE 30, 1995; AND TO PROVIDE FOR THE ADDITIONAL  
30 APPROPRIATION OF STATE AND FEDERAL FUNDS FOR THE EXECUTIVE  
31 DEPARTMENT OF THE COMMONWEALTH FOR THE FISCAL YEAR JULY 1,

1 1994, TO JUNE 30, 1995, AND FOR THE PAYMENT OF BILLS INCURRED  
2 AND REMAINING UNPAID AT THE CLOSE OF THE FISCAL YEAR ENDING  
3 JUNE 30, 1994," MAKING ADDITIONAL APPROPRIATIONS FROM THE  
4 GENERAL FUND TO THE DEPARTMENT OF AGRICULTURE, THE DEPARTMENT  
5 OF EDUCATION, THE DEPARTMENT OF HEALTH AND THE ORGAN DONATION  
6 AWARENESS TRUST FUND; AND MAKING an appropriation from the  
7 State Employees' Retirement Fund to provide for expenses of  
8 the State Employees' Retirement Board for the fiscal year  
9 July 1, 1995, to June 30, 1996, and for the payment of bills  
10 incurred and remaining unpaid at the close of the fiscal year  
11 ending June 30, 1995.

12 The General Assembly of the Commonwealth of Pennsylvania  
13 hereby enacts as follows:

14 ~~Section 1. The sum of \$15,850,000, or as much thereof as may <—~~  
15 ~~be necessary, is hereby appropriated from the State Employees'~~  
16 ~~Retirement Fund to the State Employees' Retirement Board for the~~  
17 ~~payment of all salaries, wages and other compensation and travel~~  
18 ~~expenses of the employees and members of the State Employees'~~  
19 ~~Retirement Board, for contractual services and other expenses~~  
20 ~~necessary for the proper conduct of the duties, functions and~~  
21 ~~activities of the board for the fiscal year beginning July 1,~~  
22 ~~1995, and for the payment of bills incurred and remaining unpaid~~  
23 ~~at the close of the fiscal year ending June 30, 1995.~~

24 ~~Section 2. This act shall take effect July 1, 1995, or~~  
25 ~~immediately, whichever is later.~~

26 SECTION 1. SHORT TITLE.--THIS ACT SHALL BE KNOWN AND MAY BE <—  
27 CITED AS THE FIRST SUPPLEMENTAL APPROPRIATION ACT FOR 1995-1996.

28 SECTION 2. DEPARTMENT OF  
29 AGRICULTURE.--THE FOLLOWING AMOUNTS  
30 ARE APPROPRIATED TO THE DEPARTMENT OF  
31 AGRICULTURE: FEDERAL STATE  
32 FOR GRANTS FOR AGRICULTURAL  
33 RESEARCH PROGRAMS AT LAND GRANT  
34 UNIVERSITIES.

35 STATE APPROPRIATION..... 2,850,000

1 FOR GRANTS FOR THE OPERATION OF  
2 ESTABLISHED AGRICULTURAL EXTENSION  
3 SERVICES.

4 STATE APPROPRIATION..... 876,000

5 SECTION 3. DEPARTMENT OF  
6 EDUCATION.--THE FOLLOWING AMOUNTS ARE  
7 APPROPRIATED TO THE DEPARTMENT OF  
8 EDUCATION:

FEDERAL STATE

9 FOR AN EXPANSION OF EXISTING  
10 PSYCHIATRY SERVICES IN CENTRAL  
11 PENNSYLVANIA PROVIDED BY A LAND GRANT  
12 UNIVERSITY.

13 STATE APPROPRIATION..... 432,000

14 SECTION 4. DEPARTMENT OF HEALTH.--  
15 THE FOLLOWING AMOUNTS ARE APPROPRIATED  
16 TO THE DEPARTMENT OF HEALTH:

FEDERAL STATE

17 FOR A GRANT TO A NONPROFIT MEDICAL  
18 CONSORTIUM PROVIDING CANCER CONTROL  
19 AND PREVENTION PROGRAMS TO A 34-COUNTY  
20 AREA IN CENTRAL PENNSYLVANIA.

21 STATE APPROPRIATION..... 100,000

22 FOR A GRANT TO A CANCER RESEARCH  
23 INSTITUTE LOCATED IN A CITY OF THE  
24 FIRST CLASS.

25 STATE APPROPRIATION..... 150,000

26 FOR A GRANT TO A FOUNDATION IN A  
27 CITY OF THE FIRST CLASS PROVIDING  
28 INPATIENT AND OUTPATIENT SERVICES AND  
29 TREATMENT FOR BURN VICTIMS.

30 STATE APPROPRIATION..... 100,000

30       SECTION 7.   CONSTRUCTION.--THE APPROPRIATIONS IN SECTIONS 2,

1 3 AND 4 OF THIS ACT ARE IN ADDITION TO ANY OTHER APPROPRIATIONS  
2 MADE FOR THE SAME OR SIMILAR PURPOSES FOR THE FISCAL YEAR JULY  
3 1, 1995, TO JUNE 30, 1996.

4 SECTION 8. EFFECTIVE DATE.--THIS ACT SHALL TAKE EFFECT JULY  
5 1, 1995, OR IMMEDIATELY, WHICHEVER IS LATER.
