AN ACT

- Amending the act of April 9, 1929 (P.L.177, No.175), entitled 2 "An act providing for and reorganizing the conduct of the 3 executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative 5 departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or 6 7 Teachers Colleges; abolishing, creating, reorganizing or 8 authorizing the reorganization of certain administrative 9 departments, boards, and commissions; defining the powers and duties of the Governor and other executive and administrative 10 11 officers, and of the several administrative departments, 12 boards, commissions, and officers; fixing the salaries of the Governor, Lieutenant Governor, and certain other executive 13 14 and administrative officers; providing for the appointment of 15 certain administrative officers, and of all deputies and 16 other assistants and employes in certain departments, boards, 17 and commissions; and prescribing the manner in which the 18 number and compensation of the deputies and all other 19 assistants and employes of certain departments, boards and 20 commissions shall be determined, " providing for notification 21 of certain licenses, permits and contracts to municipalities.
- 22 The General Assembly of the Commonwealth of Pennsylvania
- 23 hereby enacts as follows:
- 24 Section 1. The act of April 9, 1929 (P.L.177, No.175), known
- 25 as The Administrative Code of 1929, is amended by adding a
- 26 section to read:

- 1 Section 531. Notification of Local Government.--A
- 2 Commonwealth agency that proposes to issue a license or permit
- 3 or enter into a contract for services to be provided for a
- 4 period of sixty (60) days or more or for construction or
- 5 operation of a facility shall provide written notification of
- 6 the proposed license, permit or contract to the elected
- 7 officials of the affected city, borough, incorporated town or
- 8 township and to the county governing body. The notification
- 9 shall occur at least thirty (30) days prior to the issuance of
- 10 the license or permit or signing of the contract. The elected
- 11 officials may request, within thirty (30) days of notification
- 12 by the agency, a public hearing to allow public input on the
- 13 <u>license</u>, <u>permit or contract</u>. The hearing shall be held in the
- 14 political subdivision where the license, permit or contract is
- 15 to be issued or performed. The agency shall hold the public
- 16 <u>hearing within sixty (60) days of the request made by the</u>
- 17 elected officials.
- 18 Section 2. This act shall take effect in 60 days.
