## A JOINT RESOLUTION

- 1 Proposing amendments to the Constitution of the Commonwealth of
- 2 Pennsylvania, providing for concurrence of three-fifths of
- 3 all members of each House for the passage of measures
- 4 imposing new taxes or license fees; and further providing for
- 5 Commonwealth indebtedness.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby resolves as follows:
- 8 Section 1. The following amendments to the Constitution of
- 9 Pennsylvania are proposed in accordance with Article XI:
- 10 (1) That section 4 of Article III be amended to read:
- 11 § 4. Consideration of bills.
- 12 Every bill shall be considered on three different days in
- 13 each House. All amendments made thereto shall be printed for the
- 14 use of the members before the final vote is taken on the bill
- 15 and before the final vote is taken, upon written request
- 16 addressed to the presiding officer of either House by at least
- 17 25% of the members elected to that House, any bill shall be read
- 18 at length in that House. No bill shall become a law, unless on

- 1 its final passage the vote is taken by yeas and nays, the names
- 2 of the persons voting for and against it are entered on the
- 3 journal, and a majority of the members elected to each House is
- 4 recorded thereon as voting in its favor. No tax or license fee
- 5 or increase of any tax or license fee shall be imposed except
- 6 pursuant to an act of the General Assembly adopted with the
- 7 concurrence of three-fifths of all members of each House.
- 8 (2) That section 7 of Article VIII be amended by adding a
- 9 subsection to read:
- 10 § 7. Commonwealth indebtedness.
- 11 \* \* \*
- 12 (e) To make up for insufficient revenues, the General
- 13 Assembly may, where necessary, increase the rate of taxes and
- 14 fees after the failure to pay, when due, the principal and
- 15 <u>interest on the debt.</u>
- 16 Section 2. That no inconvenience may arise from changes in
- 17 Article III of the Constitution of Pennsylvania, it is hereby
- 18 declared that this amendment shall not apply to any tax or
- 19 license fee authorized by an act of the General Assembly but not
- 20 effective on the effective date of this amendment.
- 21 Section 3. (a) Upon the first passage by the General
- 22 Assembly of these proposed constitutional amendments, the
- 23 Secretary of the Commonwealth shall proceed immediately to
- 24 comply with the advertising requirements of section 1 of Article
- 25 XI of the Constitution of Pennsylvania and shall transmit the
- 26 required advertisements to two newspapers in every county in
- 27 which such newspapers are published in sufficient time after
- 28 passage of these proposed constitutional amendments.
- 29 (b) Upon the second passage by the General Assembly of these
- 30 proposed constitutional amendments, the Secretary of the

- 1 Commonwealth shall proceed immediately to comply with the
- 2 advertising requirements of section 1 of Article XI of the
- 3 Constitution of Pennsylvania and shall transmit the required
- 4 advertisements to two newspapers in every county in which such
- 5 newspapers are published in sufficient time after passage of
- 6 these proposed constitutional amendments. The Secretary of the
- 7 Commonwealth shall submit these proposed constitutional
- 8 amendments to the qualified electors of this Commonwealth at the
- 9 first primary, general or municipal election occurring at least
- 10 three months after the proposed constitutional amendments are
- 11 passed by the General Assembly which meets the requirements of
- 12 and is in conformance with section 1 of Article XI of the
- 13 Constitution of Pennsylvania.
