- 1 Amending Title 42 (Judiciary and Judicial Procedure) of the
- 2 Pennsylvania Consolidated Statutes, further providing for
- 3 limitation of certain Vehicle Code prosecutions.

- 5 hereby enacts as follows:
- 6 Section 1. Section 5553(e) of Title 42 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 5553. Summary offenses involving vehicles.

- 10 (e) Disposition of proceedings [within two years].--No
- 11 proceedings shall be held or action taken [pursuant] by the
- 12 minor judiciary as follows:
- 13 (1) Pursuant to a nonmoving summary offense under Title
- 14 75, subsequent to two years after the commission of the
- offense.
