AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- 2 Statutes, further providing for handicapped placard; and
- 3 providing for certain special registration plates.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Sections 1334, 1338 and 1342 of Title 75 of the
- 7 Pennsylvania Consolidated Statutes are amended to read:
- 8 § 1334. Return of registration plate.
- 9 (a) General rule. -- Registration plates shall be returned to
- 10 the department under the following circumstances:
- 11 (1) A registration plate shall be returned if the
- 12 registrant no longer has a vehicle titled in this
- 13 Commonwealth.
- 14 (2) A legislative registration plate shall be returned
- on the expiration or termination of the term of office of the
- legislative member.
- 17 (3) A dealer or "Miscellaneous Motor Vehicle Business"
- 18 registration plate shall be returned if the business is

- 1 discontinued.
- 2 (4) A [handicapped] <u>disability</u> registration plate shall
- 3 be returned if the person to whom it was issued no longer
- 4 qualifies under section 1338 (relating to [handicapped]
- 5 <u>disability</u> plate and placard).
- 6 (b) Time for return of plate. -- Each registration plate
- 7 required to be returned under this section shall be returned to
- 8 the department within five days of the occurrence requiring its
- 9 return.
- 10 (c) Statement accompanying returned plate.--Each returned
- 11 registration plate shall be accompanied by a statement of the
- 12 reason for the return of the plate and the date of the
- 13 occurrence requiring its return.
- 14 § 1338. [Handicapped] <u>Disability</u> plate and placard.
- 15 (a) [Handicapped] <u>Disability</u> plate. -- On the application of
- 16 any person who:
- 17 (1) is blind;
- 18 (2) does not have full use of an arm or both arms;
- 19 (3) cannot walk 200 feet without stopping to rest;
- 20 (4) cannot walk without the use of, or assistance from,
- a brace, cane, crutch, another person, prosthetic device,
- 22 wheelchair or other assistive device;
- 23 (5) is restricted by lung disease to such an extent that
- the person's forced (respiratory) expiratory volume for one
- second, when measured by spirometry, is less than one liter
- or the arterial oxygen tension is less than 60 mm/hg on room
- 27 air at rest;
- 28 (6) uses portable oxygen;
- 29 (7) has a cardiac condition to the extent that the
- 30 person's functional limitations are classified in severity as

- 1 Class III or Class IV according to the standards set by the
- 2 American Heart Association;
- 3 (8) is severely limited in his or her ability to walk
- 4 due to an arthritic, neurological or orthopedic condition; or
- 5 (9) is a person in loco parentis of a person specified
- 6 in paragraph (1), (2), (3), (4), (5), (6), (7) or (8);
- 7 the department shall issue a special registration plate for one
- 8 passenger car or other vehicle with a registered gross weight of
- 9 not more than 9,000 pounds, designating the vehicle so licensed
- 10 as being used by a [handicapped] person with a disability.
- 11 Special plates for [handicapped] persons with disabilities may
- 12 also be issued for vehicles operated exclusively for the use and
- 13 benefit of [handicapped] such persons. In the case of a
- 14 motorcycle, the department shall issue a decal containing the
- 15 international symbol for [handicapped] access by individuals
- 16 <u>with disabilities</u> for display on the registration plate.
- 17 (b) [Handicapped] <u>Disability</u> parking placard.--On the
- 18 initial application or renewal application of any person who
- 19 meets the qualifications of subsection (a), the department shall
- 20 issue one special parking placard of such size and design as the
- 21 department shall specify, designating the vehicle in which it is
- 22 displayed as being used for the transportation of a
- 23 [handicapped] person with a disability. When parking the
- 24 designated vehicle, the [handicapped] disability parking placard
- 25 shall be prominently displayed in such a manner that it may be
- 26 viewed from the front and rear of the vehicle by hanging it from
- 27 the front windshield rearview mirror of a vehicle only when that
- 28 vehicle is utilizing a parking space reserved for persons with
- 29 disabilities. When there is no rearview mirror, or the placard
- 30 is not designed in such a manner to accommodate hanging from a

- 1 rearview mirror, the placard shall be displayed on the
- 2 dashboard. Placards may also be issued for use in vehicles when
- 3 operated for the use and benefit of [handicapped] persons with
- 4 <u>disabilities</u>. Organizations which transport persons in vehicles
- 5 operated for the use and benefit of handicapped persons shall be
- 6 issued not more than eight placards in the organization's name.
- 7 [(c) Physician's statement.--
- 8 (1) Any person applying for a special plate or parking
- 9 placard for handicapped persons must present a statement,
- 10 certified by a physician licensed to practice in this
- 11 Commonwealth or in a contiguous state, that the handicapped
- person is handicapped as provided in subsection (a).
- 13 (2) Any person applying for a renewal of registration of
- 14 a special plate for handicapped persons must comply with this
- subsection. Once a handicapped person has been duly certified
- by a physician as being handicapped, as provided in
- 17 subsection (a), the applicant need not submit a certification
- for subsequent renewals of registration for a special plate
- 19 for handicapped persons. A person who was issued a
- 20 handicapped plate under this section and no longer qualifies
- 21 for one shall not be charged a replacement fee for a regular
- registration plate upon payment of the regular registration
- 23 fee.
- 24 (3) In lieu of a physician's statement, a person
- applying for a special plate or parking placard may present a
- 26 statement from a police officer certifying that the person
- does not have full use of a leg, or both legs, or is blind.
- 28 (4) The department shall phase out existing handicapped
- 29 placards as soon as practicable and issue a new series to
- 30 persons who comply with this section.]

- 1 (c) Physician's statement.--Except as provided in subsection
- 2 (d), a person applying for a special plate or parking placard
- 3 for a person with a disability must present a statement,
- 4 <u>certified by a physician licensed to practice in this</u>
- 5 Commonwealth or in a contiguous state, that the person has a
- 6 <u>disability as provided in subsection (a). Once a person has been</u>
- 7 <u>duly certified by a physician as having a disability, as</u>
- 8 provided in subsection (a), the applicant need not submit a
- 9 <u>certification for subsequent renewals of registration for a</u>
- 10 special plate for a person with a disability. A person who was
- 11 <u>issued a disability plate under this section and no longer</u>
- 12 qualifies for one shall not be charged a replacement fee for a
- 13 regular registration plate upon payment of the regular
- 14 registration fee.
- 15 (d) Exceptions. -- In lieu of a physician's statement, a
- 16 person applying for a special plate or parking placard may
- 17 present a statement from a police officer certifying that the
- 18 person does not have full use of a leg, or both legs, or is
- 19 blind or a statement from an organization dedicated to helping
- 20 persons with disabilities that the organization is providing
- 21 transportation for such persons.
- 22 [(c.1)] (e) Return of plates and placard.--Upon the death of
- 23 a person to whom a plate or placard has been issued under this
- 24 section, the plate or placard shall be void 30 days after death
- 25 and shall not be displayed on any vehicle. The personal
- 26 representative of the deceased shall return the plate to the
- 27 department. If there is no personal representative, the spouse
- 28 or, if there is no spouse, the next of kin of the deceased shall
- 29 return the plate or placard to the department.
- 30 [(c.2)] <u>(f)</u> Authorized use.--This section shall not preclude

- 1 the operation of a vehicle which bears a handicapped plate when
- 2 the vehicle is not being used for the benefit of the handicapped
- 3 person or when the handicapped person is not present in the
- 4 vehicle, provided the driver does not use or attempt to use any
- 5 special privilege or benefit otherwise accorded to vehicles
- 6 displaying the plate.
- 7 [(d)] (g) Penalty.--Any person violating this section
- 8 commits a summary offense and shall, upon conviction, be
- 9 sentenced to pay a fine of not more than \$100.
- 10 § 1342. Veteran plates and placard.
- 11 (a) [Severely disabled veteran] <u>Veteran with severe</u>
- 12 <u>disability</u> plate. -- On the application of a veteran whose
- 13 service-connected disability is certified at 100% by the service
- 14 unit of the armed forces in which the veteran served or by the
- 15 United States Veterans' Administration or who has a service-
- 16 connected disability of the type enumerated in section 1338
- 17 (relating to [handicapped] disability plate and placard), the
- 18 department shall issue a special registration plate designating
- 19 the vehicle as belonging to a [severely disabled] veteran with a
- 20 <u>severe disability</u>. The registration plate shall have a white
- 21 background, shall have blue numbers or letters as the department
- 22 may determine, shall have the words, "[disabled] veteran with
- 23 <u>disability</u>," in at least ten-point bold type, inscribed in red
- 24 at the bottom of the plate, and shall include the international
- 25 symbol for [handicapped] access by individuals with
- 26 <u>disabilities</u>. Only one special registration plate shall be
- 27 issued to a veteran under this section. It may be used only on
- 28 one passenger vehicle or one other vehicle with a registered
- 29 gross weight of not more than 9,000 pounds. In the case of a
- 30 motorcycle, the department shall issue a decal containing the

- 1 international symbol for [handicapped] access by individuals
- 2 <u>with disabilities</u> and the words "[disabled] veteran <u>with</u>
- 3 <u>disability</u>" for display on the registration plate.
- 4 (b) [Severely disabled veteran] <u>Veteran with severe</u>
- 5 <u>disability</u> placard. --On the application of any person who meets
- 6 the qualifications of subsection (a), the department shall issue
- 7 one special parking placard of such size and design as the
- 8 department shall specify, designating the vehicle in which it is
- 9 displayed as being used for the transportation of a [severely
- 10 disabled] veteran with a severe disability. Such placard shall
- 11 be prominently displayed on the right front dash of the vehicle
- 12 when it is in use for the transportation of such [severely
- 13 disabled] veteran with a severe disability.
- 14 (c) [Disabled veteran] <u>Veteran with disability</u> plates.--On
- 15 the application of any veteran having a disability certified by
- 16 the service unit of the armed forces in which the veteran served
- 17 or by the United States Veterans' Administration as service-
- 18 connected, the department shall issue a special registration
- 19 plate designating the vehicle as belonging to a [disabled]
- 20 veteran who is disabled. The registration plate shall have a
- 21 white background, shall have numbers or letters as the
- 22 department may determine and shall have the words "[disabled]
- 23 veteran with disability" in at least ten-point bold type
- 24 inscribed at the bottom of the plate. Only one special
- 25 registration plate shall be issued to a veteran under this
- 26 section. It may be used only on one passenger vehicle or one
- 27 other vehicle with a registered gross weight of not more than
- 28 9,000 pounds.
- 29 (d) Prisoner of war plate. -- On the application of an ex-
- 30 prisoner of war whose imprisonment while in the service of the

- 1 armed forces of the United States is certified by the
- 2 appropriate branch of the armed forces, the department shall
- 3 issue a special registration plate designating the vehicle as
- 4 belonging to an ex-prisoner of war. The registration plate shall
- 5 contain the letters "POW" and such other numbers or letters as
- 6 the department may determine and shall have the words "prisoner
- 7 of war" in at least ten-point bold type inscribed at the bottom
- 8 of the plate. The special registration plate may be used only on
- 9 one passenger vehicle or one other vehicle with a registered
- 10 gross weight of not more than 9,000 pounds.
- 11 (e) Documentation of eligibility. -- The department may
- 12 require current holders of disabled veteran registration plates
- 13 and placards to provide documentation of their eligibility under
- 14 this section where current documentation is not sufficient.
- 15 (f) Return of plates and placard.--Upon the death of a
- 16 veteran to whom a [severely disabled] veteran with a severe
- 17 disability plate or placard has been issued under this section,
- 18 the [severely disabled] veteran with a severe disability plate
- 19 or placard shall be void 30 days after death and shall not be
- 20 displayed on any vehicle. The personal representative of the
- 21 deceased shall return the plate to the department. If there is
- 22 no personal representative, the spouse or, if there is no
- 23 spouse, the next of kin of the deceased shall return the plate
- 24 or placard to the department.
- 25 Section 2. Title 75 is amended by adding sections to read:
- 26 § 1360. Special plates for recipients of Silver Star.
- 27 <u>Upon application of a person who is a recipient of the Silver</u>
- 28 Star, accompanied by a fee of \$20 which shall be in addition to
- 29 the annual registration fee and by such documentation as the
- 30 department shall require, the department shall issue to the

- 1 person a special registration plate designating the vehicle so
- 2 <u>licensed as belonging to a person who is a recipient of the</u>
- 3 Silver Star. The special registration plate may be used on only
- 4 one passenger vehicle or one other vehicle with a registered
- 5 gross weight of not more than 9,000 pounds.
- 6 § 1361. Special plates for recipients of the Army Distinguished
- 7 <u>Service Cross, Navy Cross or Air Force Cross.</u>
- 8 Upon application of a person who is a recipient of the Army
- 9 <u>Distinguished Service Cross, Navy Cross or Air Force Cross,</u>
- 10 accompanied by a fee of \$20 which shall be in addition to the
- 11 <u>annual registration fee and by such documentation as the</u>
- 12 <u>department shall require</u>, the department shall issue to that
- 13 person a special registration plate designating the vehicle so
- 14 licensed as belonging to a person who is a recipient of the Army
- 15 <u>Distinguished Service Cross, Navy Cross or Air Force Cross. The</u>
- 16 special registration plate may be used on only one passenger
- 17 vehicle or one other vehicle with a registered gross weight of
- 18 not more than 9,000 pounds.
- 19 Section 3. This act shall take effect as follows:
- 20 (1) The addition of 75 Pa.C.S. §§ 1360 and 1361 shall
- 21 take effect in 60 days.
- 22 (2) The remainder of this act shall take effect
- 23 immediately.
