- 6 hereby enacts as follows:
- 7 Section 1. Sections 2313 and 6382 of Title 23 of the
- 8 Pennsylvania Consolidated Statutes are amended by adding

- 10 § 2313. Representation.

- (c) Immunity. -- Any person appointed by the court, pursuant
- 13 to this section, to represent the interests of a minor child in
- 14 any capacity in a civil, delinquent juvenile or dependency
- 15 proceeding on behalf of a minor child shall be presumed, prima
- 16 facie, to be acting in good faith and, in so doing, shall be
- 17 immune from any civil liability that otherwise might be incurred
- 18 or imposed based upon such representation.
