## AN ACT

- Amending the act of May 29, 1956 (1955 P.L.1804, No.600), entitled, as amended, "An act providing for the establishment 2 3 of police pension funds or pension annuities in certain boroughs, towns and townships; authorizing the establishment 4 5 of police pension funds or pension annuities by regional police departments; providing for the regulation and 7 maintenance of police pension funds or pension annuities; providing for an actuary; continuance of existing funds or 8 9 transfer thereof to funds herein established; prescribing 10 rights of beneficiaries; contributions by members; providing 11 for expenses of administration; continuation of existing 12 authority to provide annuity contracts; credit for military service; refunds; exempting allowances from judicial process; 13 14 and repealing certain acts, "further providing for length of 15 service for pension eligibility.
- 16 The General Assembly of the Commonwealth of Pennsylvania
- 17 hereby enacts as follows:
- 18 Section 1. Section 3 of the act of May 29, 1956 (1955)
- 19 P.L.1804, No.600), referred to as the Municipal Police Pension
- 20 Law, amended May 10, 1996 (P.L.162, No.33) is amended to read:
- 21 Section 3. Each ordinance or resolution establishing a
- 22 police pension fund shall prescribe a minimum period of total
- 23 service in the aggregate of [twenty-five years] not less than

- 1 <u>twenty years</u>, in the same borough, town, township or regional
- 2 police department and [shall fix the age of the members of the
- 3 force at fifty-five years, or, if an actuarial study of the cost
- 4 shows that such reduction in age is feasible, may fix the age of
- 5 the members of the force at fifty years,] shall not fix a
- 6 minimum age after which [they] the members of the force may
- 7 retire from active duty, and such members as are retired shall
- 8 be subject to service, from time to time, as a police reserve,
- 9 in cases of riot, tumult or preservation of the public peace
- 10 until unfitted for such service, when they may be finally
- 11 discharged by reason of age or disability.
- 12 Section 2. This act shall take effect in 60 days.
