AN ACT

- Amending the act of June 24, 1937 (P.L.2017, No.396), entitled 2 "An act creating in each county (except of the first class) 3 as a separate corporation, and in each city of the first and 4 second class as a part of the city government, an institution 5 district for the care and maintenance of certain indigent persons and children; prescribing the powers and duties of 7 county commissioners, county treasurers, city departments of public welfare, the State Department of Welfare and the State 8 9 Department of Public Assistance in respect thereto; 10 abolishing certain poor districts and terminating the terms 11 of directors, overseers, quardians and managers of the poor 12 and poor district auditors, and providing for the temporary 13 employment of certain of them; providing for the transfer, 14 vesting, sale and disposition of the property of poor districts and the payment of their obligations; imposing 15 16 certain existing obligations on institution districts and on 17 the Commonwealth; regulating the affairs of poor districts 18 until abolished; revising, amending, changing and consolidating the law relating to the care of the poor; and 19 20 repealing existing laws," further providing for burial of 21 dependents and other persons.
- The General Assembly of the Commonwealth of Pennsylvania
- 23 hereby enacts as follows:
- Section 1. Section 403 of the act of June 24, 1937
- 25 (P.L.2017, No.396), known as the County Institution District
- 26 Law, amended December 22, 1965 (P.L.1162, No.455), is amended to

- 2 Section 403. Provision for Burial or Cremation of Dependents
- 3 and Other Persons. -- Except as otherwise provided by law, the
- 4 local authorities of any institution district shall provide for
- 5 the burial or cremation of any person who dies in the county or
- 6 city, unless his body is claimed by a relative by blood or
- 7 marriage, or by a friend, or by his fraternal or veterans'
- 8 organization, or by a charitable organization or by the
- 9 Anatomical Board of the State of Pennsylvania, and is buried at
- 10 the expense of such relative, friend or organization. [No such
- 11 burial shall cost more than three hundred dollars.] <u>Upon receipt</u>
- 12 <u>from the funeral director or other person conducting the burial</u>
- 13 or cremation of an itemized statement of the costs incurred in
- 14 connection with the burial or cremation, the county or city
- 15 <u>shall contribute the sum of twelve hundred dollars toward such</u>
- 16 costs. The funeral director or other person conducting the
- 17 burial or cremation shall notify the county or city promptly of
- 18 any resources of which the director or person knows or learns
- 19 which resources, to the extent they are collected by the
- 20 <u>director or person, shall effect a reduction in the amount which</u>
- 21 the county or city shall pay toward the burial or cremation.
- 22 Section 2. This act shall take effect in 60 days.
