AN ACT

- 1 Requiring the Attorney General to collect data on traffic stops.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Short title.
- 5 This act shall be known and may be cited as the Traffic Stops
- 6 Statistics Study Act.
- 7 Section 2. Attorney General to collect data.
- 8 The Attorney General shall conduct a study of stops for
- 9 routine traffic violations by law enforcement officers in this
- 10 Commonwealth. The study shall include collection and analysis of
- 11 appropriate available data and shall consider the following
- 12 factors:
- 13 (1) The number of individuals stopped for routine
- 14 traffic violations.
- 15 (2) Identifying characteristics of the individual
- 16 stopped, including the race or ethnicity as well as the

- 1 approximate age of that individual.
- 2 (3) The traffic infraction alleged to have been
- 3 committed that led to the stop.
- 4 (4) Whether a search was instituted as a result of the
- 5 stop.
- 6 (5) The manner in which the search was instituted.
- 7 (6) The rationale for the search.
- 8 (7) Whether any contraband was discovered in the course
- 9 of the search.
- 10 (8) The nature of such contraband.
- 11 (9) Whether any warning or citation was issued as a
- 12 result of the stop.
- 13 (10) Whether an arrest was made as a result of either
- 14 the stop or the search
- 15 (11) The benefit of traffic stops with regard to the
- 16 interdiction of drugs and the proceeds of drug trafficking,
- including the approximate quantity of drugs and value of drug
- 18 proceeds seized on an annual basis as a result of routine
- 19 traffic stops.
- 20 (12) Other factors as deemed appropriate by the Attorney
- 21 General.
- 22 Section 3. Limitation on use of data.
- 23 Data acquired under this act shall be used only for research
- 24 or statistical purposes and may not contain any information that
- 25 may reveal the identity of any individual who is stopped or any
- 26 law enforcement officer. Data acquired under this act shall not
- 27 be used in any legal or administrative proceeding to establish
- 28 an inference of discrimination on the basis of particular
- 29 identifying characteristics.
- 30 Section 4. Report to General Assembly.

- 1 Not later than two years after the date of this act, the
- 2 Attorney General shall report the results of the study conducted
- 3 under this act to the General Assembly.
- 4 Section 5. Effective date.
- 5 This act shall take effect in 60 days.
