AN ACT

- 1 Amending Title 42 (Judiciary and Judicial Procedure) of the
- 2 Pennsylvania Consolidated Statutes, providing for court
- appointed special advocates in juvenile matters.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 6302 of Title 42 of the Pennsylvania
- 7 Consolidated Statutes is amended by adding definitions to read:
- 8 § 6302. Definitions.
- 9 The following words and phrases when used in this chapter
- 10 shall have, unless the context clearly indicates otherwise, the
- 11 meanings given to them in this section:
- 12 "CASA program." Any local court-administered or court-
- 13 approved program that utilizes trained citizen volunteers
- 14 appointed by the court pursuant to standards adopted by the
- 15 Juvenile Court Judges' Commission to advocate on behalf of

- 1 dependent children and alleged dependent children involved in
- 2 <u>juvenile court proceedings</u>.
- 3 * * *
- 4 "Court appointed special advocate" or "CASA." A trained
- 5 citizen volunteer appointed by the court to advocate on behalf
- 6 of dependent children and alleged dependent children involved in
- 7 juvenile court proceedings.
- 8 * * *
- 9 <u>"Juvenile Court Judges' Commission." The commission as</u>
- 10 described in the act of December 21, 1959 (P.L.1962, No.717),
- 11 entitled "An act providing for the creation and operation of the
- 12 <u>Juvenile Court Judges' Commission in the Department of Justice;</u>
- 13 prescribing its powers and duties; and making an appropriation."
- 14 * * *
- 15 Section 2. Title 42 is amended by adding a section to read:
- 16 § 6342. Court appointed special advocates.
- 17 (a) General rule. -- The court, at any stage of a juvenile
- 18 court proceeding involving a dependent child or a child alleged
- 19 to be a dependent child, has the authority to appoint a
- 20 volunteer court appointed special advocate (CASA) who shall
- 21 <u>serve until discharged by the court and whose primary duties</u>
- 22 shall be to obtain an understanding of the child's situation and
- 23 needs, and to make recommendations to the court to assist the
- 24 court in determining a disposition that is best suited to the
- 25 protection and physical, mental and moral welfare of the child.
- 26 (b) Immunity. -- Any person so appointed as a court appointed
- 27 special advocate shall be presumed prima facie to be acting in
- 28 good faith and in doing so shall be immune from any liability,
- 29 civil or criminal, that otherwise might be incurred or imposed.
- 30 (c) Oualifications. -- Any volunteers appointed by the court

| 1 | to serve as a CASA shall meet all of the following: |

| 3 | (2) Have successfully passed screening requirements, |
| 4 | including criminal and child abuse history background checks. |
| 5 | (3) Have successfully completed the training |

| 8 | (4) Remain under the supervision of the local CASA |
| 9 | program. |
| 10 | (5) Serve at the discretion of the court, in |
| 11 | consultation with the local CASA program director. |
| 12 | (d) Powers A CASA appointed by the court shall: |
| 13 | (1) have full access to and shall be provided with |
| 14 | copies of any records, including those under 23 Pa.C.S. Ch. |
| 15 | 63 (relating to child protective services) relating to the |
| 16 | child involved in the case to which the CASA has been |
| 17 | assigned, without the consent of the child or the parent, |
| 18 | provided that the confidentiality of any such information |
| 19 | shall be maintained and that the information shall be |
| 20 | utilized only in the performance of assigned duties; |
| 21 | (2) have full and unlimited access to any child to whose |
| 22 | case the CASA has been assigned; |
| 23 | (3) be given reasonable prior notice of and have the |
| 24 | opportunity to attend all hearings, staff meetings, |
| 25 | investigations or other proceedings or meetings relating to |
| 26 | the case of a child to which they have been assigned; |
| 27 | (4) be given reasonable prior notice of intent to move a |
| 28 | child from one placement to another placement, or to return a |
| 29 | child home, or to remove a child from his or her home, if the |
| 30 | child's case has been assigned to the CASA and there has been |

- 1 no court approval for any such action;
- 2 (5) assist the court in determining what disposition
- 3 <u>under section 6351 (relating to disposition dependent child)</u>
- 4 or modification thereto is best suited to the protection and
- 5 physical, mental and moral welfare of the child, by
- 6 <u>investigating all relevant aspects of the child's situation</u>
- 7 and submitting reports and recommendations to the court; and
- 8 (6) be given reasonable prior notice of any actions
- 9 <u>materially affecting the status of treatment of a child to</u>
- whose case the CASA has been assigned.
- 11 (e) Duties. -- Any volunteer appointed to serve as a CASA
- 12 shall be assigned duties, consistent with standards adopted by
- 13 the Juvenile Court Judges' Commission, which shall include, but
- 14 are not limited to:
- 15 (1) reviewing records pertaining to the child involved
- in the case to which the CASA has been assigned, with the
- 17 exception of records to which access is limited by the court;
- 18 (2) interviewing appropriate persons;
- 19 (3) monitoring the progress of the case;
- 20 (4) preparing reports and making recommendations to the
- 21 court; and
- 22 (5) fulfilling assigned duties while maintaining the
- 23 confidentiality of information obtained pertaining to the
- child's case.
- 25 (f) Standards.--The Juvenile Court Judges's Commission shall
- 26 develop standards, in consultation with Pennsylvania CASA
- 27 program directors and upon consideration of standards and
- 28 guidelines developed by the National CASA Association, governing
- 29 the qualifications, training, appointment and duties of court
- 30 appointed special advocates.

- 1 (g) Definition. -- As used in this section, the term "person"
- shall include any director, coordinator, administrator or court 2
- 3 appointed special advocate of any CASA program as defined in
- 4 <u>section 6302 (relating to definitions).</u>
- 5 Section 3. This act shall take effect in 60 days.
