AN ACT

- 1 Amending Title 51 (Military Affairs) of the Pennsylvania
- 2 Consolidated Statutes, providing for disabled veteran's
- 3 pension.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Title 51 of the Pennsylvania Consolidated
- 7 Statutes is amended by adding a section to read:
- 8 § 7703. One hundred percent disabled veteran's pension.
- 9 (a) Amount and eligibility. -- In addition to any other
- 10 <u>assistance provided by the Commonwealth except pensions provided</u>
- 11 in sections 7701 (relating to blind veteran's pension) and 7702
- 12 (relating to paralyzed veteran's pension) and in addition to any

- 1 compensation provided by the Federal Government, every veteran
- 2 <u>determined by the United States Department of Veterans Affairs</u>
- 3 to be 100% disabled shall be paid a pension of \$100 per month.
- 4 Applications for the pensions shall be made to and in the form
- 5 prescribed by the department. The Adjutant General shall
- 6 determine the eligibility of every applicant for a pension, and
- 7 <u>his decision in the matter shall be final.</u>
- 8 (b) Regulations. -- The Adjutant General shall promulgate such
- 9 regulations as may be necessary to implement the provisions of
- 10 this section.
- 11 Section 2. This act shall take effect immediately.
