- 6 victimized by an alcohol-related crash in their lifetime; and
- WHEREAS, Mothers Against Drunk Driving (MADD) works to
- 8 eliminate incidents of drunk driving and underage drinking and
- 9 counsel those who have lost a loved one in alcohol-related
- 10 accidents; and
- 11 WHEREAS, MADD has sought solutions to problems of drunk

- 2 victim advocacy in communities throughout this Commonwealth;
