AN ACT

1 Designating a bridge on State Route 1017, over the north branch
2 of Tunkhannock Creek, as the Nicholson Borough Veterans
3 Memorial Bridge; ~~and~~ designating a bridge on State Route 33 <—
4 over the Lehigh River in Northampton County as the Gene
5 Hartzell Memorial Bridge; AND DESIGNATING A CERTAIN BRIDGE IN <—
6 LANCASTER COUNTY AS THE THADDEUS STEVENS BRIDGE.

7 The General Assembly of the Commonwealth of Pennsylvania
8 hereby enacts as follows:

9 Section 1. Nicholson Borough Veterans Memorial Bridge.

10 (a) Designation.--The bridge carrying State Route 1017 over
11 the north branch of Tunkhannock Creek in Nicholson Borough,
12 Wyoming County, is hereby designated and shall be known as the
13 Nicholson Borough Veterans Memorial Bridge.

14 (b) Signs.--The Department of Transportation shall erect and
15 maintain signs, which shall display the name of the bridge
16 designated in subsection (a), at each end of the bridge.

1 Section 2. Gene Hartzell Memorial Bridge.

2 (a) Designation authorized.--The bridge carrying State Route
3 33 over the Lehigh River in Northampton County shall be known as
4 the Gene Hartzell Memorial Bridge.

5 (b) Signs.--The Department of Transportation shall erect and
6 maintain signs at each side of the bridge displaying the name of
7 the bridge.

8 SECTION 3. THADDEUS STEVENS BRIDGE. <—

9 (A) DESIGNATION.--THE REPLACEMENT BRIDGE CARRYING STATE
10 ROUTE 72 OVER AMTRAK IN THE CITY OF LANCASTER AND MANHEIM
11 TOWNSHIP, LOCALLY KNOWN AS THE FRUITVILLE PIKE BRIDGE, IS HEREBY
12 DESIGNATED THE THADDEUS STEVENS BRIDGE.

13 (B) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
14 MAINTAIN APPROPRIATE SIGNS AT EACH END OF THE BRIDGE WHICH SHALL
15 DISPLAY THE NAME OF THE BRIDGE DESIGNATED IN SUBSECTION (A).

16 Section 3 4. Effective date. <—

17 This act shall take effect in 60 days.
