## AN ACT

- 1 Amending Title 66 (Public Utilities) of the Pennsylvania
- 2 Consolidated Statutes, further providing for
- 3 telecommunications services provided to State correctional
- 4 institutions.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 2907 of Title 66 of the Pennsylvania
- 8 Consolidated Statutes is amended to read:
- 9 § 2907. State correctional institutions.
- 10 (a) Identification of calls.--Telecommunication service
- 11 providers which provide telecommunication services to State
- 12 correctional institutions shall identify to the called party any
- 13 call made by an inmate as originating from a correctional
- 14 institution.
- 15 [(b) Collect calls.--
- 16 (1) All calls made by inmates shall be collect calls
- only.

- 1 (2) Notwithstanding paragraph (1), in the case of an
- 2 emergency, the superintendent may authorize a phone call to
- 3 be made under the supervision of staff. The charge for the
- 4 call shall be borne by the inmate.]
- 5 (b) Payment of calls.--
- 6 (1) The Department of Corrections may direct that calls
- 7 made by an inmate shall be collect calls.
- 8 (2) The Department of Corrections may provide guidelines
- 9 <u>for alternative payment methods for telephone calls made by</u>
- inmates, provided that the alternative methods are consistent
- 11 with security needs, orderly operation of the prison and the
- 12 <u>public interest.</u>
- 13 (c) No cause of action created. -- This section shall not be
- 14 construed to create any cause of action or any legal right in
- 15 any person or entity. In addition, this section is not intended
- 16 to create any right of an inmate to make a telephone call or to
- 17 <u>compel a particular method of payment.</u>
- 18 Section 2. This act shall take effect immediately.
