AN ACT

1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
2 Consolidated Statutes, further providing for identity theft.

3 The General Assembly of the Commonwealth of Pennsylvania
4 hereby enacts as follows:

5 Section 1. Section 4120(c) of Title 18 of the Pennsylvania
6 Consolidated Statutes is amended to read:

7 § 4120. Identity theft.

8 * * *

9 (c) Grading.--The offenses shall be graded as follows:

10 (1) [A] EXCEPT AS PROVIDED IN PARAGRAPH (2), A first <—
11 offense under this section is a [misdemeanor
12 of the first degree] felony of the third degree, and a second
13 or subsequent offense under this section is a felony of the

1 [third] second degree.

2 (2) When a person commits an offense under subsection

3 (a) and the victim of the offense is 60 years of age or

4 older, the grading of the offense shall be [one grade higher <—

5 than specified in paragraph (1)] A FELONY OF THE SECOND <—

6 DEGREE.

8 Section 2. This act shall take effect in 60 days.
