## AN ACT

Amending the act of April 9, 1929 (P.L.343, No.176), entitled, 2 as amended, "An act relating to the finances of the State 3 government; providing for the settlement, assessment, collection, and lien of taxes, bonus, and all other accounts due the Commonwealth, the collection and recovery of fees and 5 other money or property due or belonging to the Commonwealth, 7 or any agency thereof, including escheated property and the proceeds of its sale, the custody and disbursement or other 8 9 disposition of funds and securities belonging to or in the 10 possession of the Commonwealth, and the settlement of claims 11 against the Commonwealth, the resettlement of accounts and 12 appeals to the courts, refunds of moneys erroneously paid to 13 the Commonwealth, auditing the accounts of the Commonwealth 14 and all agencies thereof, of all public officers collecting 15 moneys payable to the Commonwealth, or any agency thereof, 16 and all receipts of appropriations from the Commonwealth, 17 authorizing the Commonwealth to issue tax anticipation notes 18 to defray current expenses, implementing the provisions of section 7(a) of Article VIII of the Constitution of 19 20 Pennsylvania authorizing and restricting the incurring of 21 certain debt and imposing penalties; affecting every department, board, commission, and officer of the State 22 government, every political subdivision of the State, and 23 24 certain officers of such subdivisions, every person, 25 association, and corporation required to pay, assess, or 26 collect taxes, or to make returns or reports under the laws imposing taxes for State purposes, or to pay license fees or 27

- 2 every State depository and every debtor or creditor of the
- Commonwealth, " prohibiting investments in corporations doing business in countries which sponsor terrorism. 3

- 5 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows:
- 7 Section 1. The act of April 9, 1929 (P.L.343, No.176), known
- 8 as The Fiscal Code, is amended by adding a section to read:
- 9 Section 301.2. Prohibition of Investments in Countries
- Identified as Sponsors of Terrorism. -- No funds shall be invested 10
- 11 under this act in any stock or obligation of any corporation
- 12 doing business, either by itself or through any subsidiary or
- affiliate, in any country identified by the United States 13
- Department of State as a sponsor of foreign terrorist 14
- 15 organizations.
- 16 Section 2. This act shall take effect immediately.
