AN ACT

Designating a bridge on State Route 44, over Little Pine Creek 2 in Lycoming County, as the Lieutenant Michael Wolf Bridge; 3 designating a portion of the Mon/Fayette Expressway, State Route 43, as the J. Barry Stout Expressway; designating a 5 portion of the Mon/Fayette Expressway, State Route 43, as the James J. Manderino Memorial Highway; designating the twin 6 7 bridges at milepost 45 of the Mon/Fayette Expressway as the 8 Joe Montana Bridges; designating State Route 1077 in Donora Borough and Carroll Township, Washington County, as the Stan 9 10 Musial Byway; designating a portion of State Route 24 in York 11 County as the 24th Infantry Division Association Highway; 12 designating a bridge on the Mon/Fayette Expressway as the Braddock's Crossing Bridge; designating a portion of the 13 14 Mon/Fayette Expressway, State Route 43, as the Medal of Honor 15 Highway; designating State Route 65 as the 65th Infantry 16 Division Memorial Highway; designating a certain bridge on 17 State Route 1002 over French Creek in Venango Borough, 18 Crawford County, as the Venango Veterans Memorial Bridge; 19 designating Exit 10 in Harborcreek Township, ERIE COUNTY, on Interstate 90 as the Trooper Matthew R. Bond Memorial 20 21 Interchange; designating a portion of U.S. Route 62, 22 Pennsylvania Route 8 in Venango County as the Colonel Francis S. Gabreski Highway; designating a portion of Kittanning 23 24 Bypass in Armstrong County as the Henry Livengood Memorial 25 Highway; designating the dam known as the Fabridam, between 26 Sunbury, Northumberland County, and Shamokin Dam, Snyder 27 County, as the Adam T. Bower Memorial Dam; designating a 28 certain bridge on State Route 655 over the Juniata River as 29 the Mapleton Area Veterans Memorial Bridge; designating a certain bridge on Interstate 79 over the Ohio River at 30 31 Neville Island as the Pittsburgh Naval and Shipbuilders

- 1 Memorial Bridge 1941-1945; and designating a bridge in the
- 2 Borough of Renovo, Clinton County, as the Pennsylvania
- 3 Railroad Bridge.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Lieutenant Michael Wolf Bridge.
- 7 (a) Designation.--The bridge carrying State Route 44, over
- 8 Little Pine Creek in Cummings Township, Lycoming County, shall
- 9 be known as the Lieutenant Michael Wolf Bridge.
- 10 (b) Signs.--The Department of Transportation shall erect and
- 11 maintain signs at each side of the bridge designated in section
- 12 1 displaying the name of the bridge.
- 13 Section 2. J. Barry Stout Expressway.
- 14 (a) Declaration of policy.--
- 15 (1) Adequate transportation systems are crucial to the
- public health, safety and economic integrity of a community.
- 17 (2) Southwestern Pennsylvania has for many years endured
- 18 congestion of traffic and poor feeder routes in the general
- 19 north-south pattern between the Monongahela Valley and the
- 20 City of Pittsburgh which have threatened the safety of the
- 21 public and thwarted economic development.
- 22 (3) The construction of a limited access road artery for
- 23 the north-south pattern in southwestern Pennsylvania from
- 24 Interstate 68 in West Virginia to the City of Pittsburgh will
- 25 relieve such congestion, promote economic vitality, reduce
- 26 the threat of catastrophe from the transportation of highly
- 27 combustible and toxic materials in densely populated areas,
- and promote the general safety, health and welfare of the
- 29 public.
- 30 (4) Since his election to the General Assembly in 1971,
- 31 J. Barry Stout of Bentleyville, Washington County, has

- 1 advocated an expanded State road network, including a
- 2 Mon/Fayette Expressway and a Southern Beltway connector which
- 3 would link to the Greater Pittsburgh International Airport.
- 4 (5) Senator J. Barry Stout has tirelessly and
- 5 relentlessly pursued construction of a north-south road
- 6 artery and its connections in furtherance of the public
- 7 safety, welfare and economic development in all of
- 8 southwestern Pennsylvania. It is a fitting tribute that a
- 9 portion of this north-south road artery be designated in his
- 10 honor.
- 11 (6) In 1985 the General Assembly passed Senate Bill
- No.441, which was signed into law as the act of September 30,
- 13 1985 (P.L.240, No.61), known as the Turnpike Organization,
- 14 Extension and Toll Road Conversion Act. Senator Stout served
- on the Committee of Conference which reached the final
- 16 agreement on the language for the landmark legislation which
- authorized the Mon/Fayette Expressway.
- 18 (b) Designation.--The Mon/Fayette Expressway, State Route
- 19 43, beginning at the interchange with Interstate 70 in
- 20 Fallowfield Township, Washington County, and continuing north to
- 21 the Allegheny County line is designated as the J. Barry Stout
- 22 Expressway. Appropriate signs shall be posted and maintained by
- 23 the Pennsylvania Turnpike Commission.
- 24 Section 3. James J. Manderino Memorial Highway.
- 25 The section of State Route 43, beginning at the interchange
- 26 with Interstate 70 in Fallowfield Township, Washington County,
- 27 and continuing south until the intersection with United States
- 28 Route 40 in Centerville and California Boroughs, Washington
- 29 County, is designated as the James J. Manderino Memorial
- 30 Highway. Appropriate signs shall be posted and maintained by the

- 1 Pennsylvania Turnpike Commission.
- 2 Section 4. Joe Montana Bridges.
- 3 The twin bridges on State Route 43 at the milepost 45 over
- 4 Mingo Creek in Union Township, Washington County near State
- 5 Route 136 and Ringgold High School are designated as the Joe
- 6 Montana Bridges. Appropriate signs shall be posted and
- 7 maintained by the Pennsylvania Turnpike Commission.
- 8 Section 5. Stan Musial Byway.
- 9 The entire length of State Route 1077 within the Borough of
- 10 Donora and Carroll Township, Washington County, is designated as
- 11 the Stan Musial Byway. The Department of Transportation shall
- 12 erect and maintain appropriate road signs.
- 13 Section 6. 24th Infantry Division Association Highway.
- 14 The portion of State Route 24 from Hopewell Township to its
- 15 terminus in Mount Wolf Borough of York County is designated and
- 16 shall be known as the 24th Infantry Division Association
- 17 Highway. The Department of Transportation shall erect and
- 18 maintain appropriate signs identifying the above portion of road
- 19 as the 24th Infantry Division Association Highway.
- 20 Section 7. Braddock's Crossing Bridge.
- 21 The bridge on the Mon/Fayette Expressway in Allegheny County
- 22 crossing the Monongahela River between Duquesne and East
- 23 Pittsburgh in Allegheny County is designated as the Braddock's
- 24 Crossing Bridge. The Pennsylvania Turnpike Commission shall
- 25 erect and maintain appropriate signs.
- 26 Section 8. The Medal of Honor Highway.
- 27 The Mon/Fayette Expressway, State Route 43, beginning at the
- 28 intersection with State Route 51 in Allegheny County and
- 29 continuing north until the connection with Interstate 376 at
- 30 Monroeville and the City of Pittsburgh in Allegheny County, is

- 1 designated as the Medal of Honor Highway. Appropriate signs
- 2 shall be posted and maintained by the Pennsylvania Turnpike
- 3 Commission.
- 4 Section 9. 65th Infantry Division Memorial Highway.
- 5 (a) Designation. -- State Route 65 beginning in the City of
- 6 Pittsburgh and ending near New Castle, Pennsylvania, is hereby
- 7 designated as the 65th Infantry Division Memorial Highway.
- 8 (b) Signs.--The Department of Transportation shall erect
- 9 appropriate signs to indicate this designation.
- 10 Section 10. Venango Veterans Memorial Bridge.
- 11 (a) Designation. -- The bridge over the French Creek, now
- 12 known as Gravel Run Bridge, on State Route 1002 in Venango
- 13 Borough, Crawford County, is hereby designated and shall be
- 14 known as the Venango Veterans Memorial Bridge.
- 15 (b) Signs.--The Department of Transportation shall erect and
- 16 maintain signs which shall display the name of Venango Veterans
- 17 Memorial Bridge at each end of the bridge so designated in
- 18 subsection (a).
- 19 Section 11. Trooper Matthew R. Bond Memorial Interchange.
- 20 (a) Declaration of policy.--
- 21 (1) Matthew R. Bond, an honored and decorated
- Pennsylvania State Police trooper, was born August 8, 1971,
- in Greensburg, Pennsylvania, graduated from Meadville Area
- 24 High School and earned a Bachelor of Science Degree in
- 25 Criminal Justice from Edinboro University of Pennsylvania.
- 26 (2) In September of 1995, Trooper Bond entered the
- 27 Pennsylvania State Police Academy and served with Troop B, in
- 28 Belle Vernon, from March of 1996 to September of 1998, and
- thereafter with Troop E in Lawrence Park.
- 30 (3) Trooper Bond received the Medal of Honor, the

- 1 highest honor in the Pennsylvania State Police, in August
- 2 1999, for rescuing a woman and her daughter from a 1998 house
- 3 fire, and served the Commonwealth with distinction until his
- 4 death on January 14, 2000, after being struck by a tractor-
- 5 trailer in the line of duty while assisting a stranded
- 6 motorist.
- 7 (b) Designation. -- The interchange in Harborcreek Township,
- 8 ERIE COUNTY, known as Exit 10 on Interstate 90 is hereby
- 9 designated as the Trooper Matthew R. Bond Memorial Interchange.
- 10 (c) Posting of signs.--The Department of Transportation
- 11 shall erect appropriate signs to indicate the designation made
- 12 by this section.
- 13 Section 12. Colonel Francis S. Gabreski Highway.
- 14 (a) Designation. -- The section of U.S. Route 62, Pennsylvania
- 15 Route 8 in Venango County from the Franklin City line at segment
- 16 320 proceeding northbound to the Oil City line at segment 470 is
- 17 hereby designated as the Colonel Francis S. Gabreski Highway.
- 18 (b) Signs.--The Department of Transportation shall erect and
- 19 maintain appropriate signs displaying the name of the highway to
- 20 both northbound and southbound traffic.
- 21 Section 13. Designation of Henry Livengood Memorial Highway.
- 22 (a) Designation. -- The Kittanning Bypass from the interchange
- 23 with S.R. 66 and S.R. 422/S.R. 28 to the intersection with S.R.
- 24 85 and S.R. 28/S.R. 66 in Armstrong County is designated and
- 25 shall be known as the Henry Livengood Memorial Highway.
- 26 (b) Erection of appropriate markers.--The Department of
- 27 Transportation shall erect and maintain appropriate signs
- 28 identifying the above portion of road as the Henry Livengood
- 29 Memorial Highway.
- 30 Section 14. Adam T. Bower Memorial Dam.

- 1 (a) Designation.--The dam known as the Fabridam and located
- 2 between Sunbury, Northumberland County, and Shamokin Dam, Snyder
- 3 County, is hereby designated the Adam T. Bower Memorial Dam.
- 4 (b) Markers to be erected. -- The Department of Conservation
- 5 and Natural Resources shall erect suitable markers on the Adam
- 6 T. Bower Memorial Dam.
- 7 Section 15. Mapleton Area Veterans Memorial Bridge.
- 8 (a) Designation.--The bridge over the Juniata River on State
- 9 Route 655, between Mapleton Borough and Brady Township,
- 10 Huntingdon County, is hereby designated and shall be known as
- 11 the Mapleton Area Veterans Memorial Bridge.
- 12 (b) Signs.--The Department of Transportation shall erect and
- 13 maintain signs which shall display the name of Mapleton Area
- 14 Veterans Memorial Bridge.
- 15 Section 16. Pennsylvania Railroad Bridge.
- 16 (a) Finding of fact. -- The General Assembly finds and
- 17 declares as follows:
- 18 (1) In 1970, HRI Incorporated built a steel, multigirder
- 19 bridge, 192 feet in length, over a section of what was then
- 20 the Pennsylvania Railroad.
- 21 (2) The bridge referred to in paragraph (1) can stand
- 22 today as a symbol of the great Pennsylvania Railroad, which
- 23 was the first great business enterprise in America.
- 24 (3) The Pennsylvania Railroad, called "the standard
- railroad of the world," was chartered on April 13, 1846. By
- 26 1854 it was a continuous rail route from Philadelphia to
- 27 Pittsburgh; and, at its pinnacle the Pennsylvania Railroad
- 28 service territory extended from Manhattan to St. Louis.
- 29 (4) The Pennsylvania Railroad connected our two largest
- 30 cities, while bringing commerce and jobs to wide ranging

- 1 parts of this Commonwealth. The hard-working employees of the
- 2 railroad who contributed so much of their blood, sweat and
- 3 tears to this Commonwealth deserve appropriate recognition.
- 4 (b) Designation authorized. -- The bridge designated by the
- 5 Department of Transportation as Bridge No. 18012004201253, which
- 6 passes over a section of the Norfolk Southern Railroad in the
- 7 borough of Renovo, Clinton County, is designated and shall be
- 8 known as the Pennsylvania Railroad Bridge.
- 9 (c) Signs.--Appropriate signs shall be posted and maintained
- 10 by the Department of Transportation.
- 11 Section 17. Pittsburgh Naval and Shipbuilders Memorial Bridge
- 12 1941-1945.
- 13 (a) Designation. -- The bridge on Interstate Route 79, over
- 14 the Ohio River at Neville Island in Allegheny County, is
- 15 designated and shall be known as the Pittsburgh Naval and
- 16 Shipbuilders Memorial Bridge 1941-1945.
- 17 (b) Signs.--The Department of Transportation shall erect and
- 18 maintain at each side of the bridge a sign displaying the name
- 19 of the bridge.
- 20 Section 18. Repeal.
- 21 All acts and parts of acts are repealed insofar as they are
- 22 inconsistent with this act.
- 23 Section 19. Effective date.
- 24 This act shall take effect as follows:
- 25 (1) Sections 1, 2, and 5 shall take effect in 60 days.
- 26 (2) Section 4 shall take effect June 11, 2001.
- 27 (3) The remainder of this act shall take effect
- immediately.
