## AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain
- 3 provisions applicable as well to private and parochial
- 4 schools; amending, revising, consolidating and changing the
- 5 laws relating thereto, " further providing for Commonwealth
- 6 reimbursements for vocational education equipment grants; and
- making an appropriation.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- 9 hereby enacts as follows:
- 10 Section 1. Section 1855 of the act of March 10, 1949
- 11 (P.L.30, No.14), known as the Public School Code of 1949, added
- 12 May 10, 2000 (P.L.44, No.16), is amended to read:
- 13 Section 1855. Vocational Education Equipment Grants.--For
- 14 the 2000-2001 fiscal year and each fiscal year thereafter, the
- 15 Department of Education shall establish a grant program to
- 16 assist area vocational-technical schools and school districts
- 17 offering approved vocational-technical programs in purchasing
- 18 equipment that meets industry standards for the purpose of
- 19 providing training to students. Grants shall be limited to the

- 1 purchase of equipment in the following program areas: automotive
- 2 technology, auto body, diesel technology, precision machine
- 3 technology, heating ventilation and air conditioning, printing,
- 4 dental assisting, electronics, building trades and other program
- 5 areas approved by the Secretary of Education. Grants shall be
- 6 awarded by the Department of Education on a matching basis, two
- 7 State dollars (\$2) for every local dollar (\$1), and shall be
- 8 limited to funds appropriated for that purpose.
- 9 Section 2. The sum of \$10,000,000, or as much thereof as may
- 10 be necessary, is hereby appropriated to the Department of
- 11 Education for the fiscal year July 1, 2001, to June 30, 2002,
- 12 for the purpose of vocational education equipment grant payments
- 13 for area vocational-technical schools and school districts.
- 14 Section 3. This act shall take effect July 1, 2001.
