- 1 Amending Title 27 (Environmental Resources) of the Pennsylvania
- 2 Consolidated Statutes, further providing for disposal fee for
- 3 municipal waste landfills and for deposit of disposal fee.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Sections 6301(a) and 6302 of Title 27 of the
- 7 Pennsylvania Consolidated Statutes are amended to read:
- 8 § 6301. Disposal fee for municipal waste landfills.
- 9 (a) Imposition.--Except as otherwise provided in subsection
- 10 (b), each operator of a municipal waste landfill shall pay, in
- 11 the same manner prescribed in Chapter 7 of the act of July 27,
- 12 1988 (P.L.556, No.101), known as the Municipal Waste Planning,
- 13 Recycling and Waste Reduction Act, a disposal fee of [\$4] \$9 per
- 14 ton for all solid waste disposed of at the municipal waste
- 15 landfill. The fee established in this section shall apply to
- 16 process residue and nonprocessible waste from a resource
- 17 recovery facility that is disposed of at the municipal waste
- 18 landfill and is in addition to the fee established in section

- 1 701 of the Municipal Waste Planning, Recycling and Waste
- 2 Reduction Act.

- 4 § 6302. Deposit of disposal fee.
- 5 The disposal fees received by the department pursuant to
- 6 <u>section 6301 (relating to disposal fee for municipal waste</u>
- 7 <u>landfills</u>) <u>shall be paid into the State Treasury as follows:</u>
- 8 (1) For the fiscal year 2002-2003[, fees received by the
- 9 department pursuant to section 6301 (relating to disposal fee
- 10 for municipal waste landfills) shall be paid into the State
- 11 Treasury as follows]:
- 12 (i) The first \$50,000,000 in fees collected shall be
- deposited into the Environmental Stewardship Fund
- established in Chapter 61 (relating to environmental
- stewardship and watershed protection).
- 16 (ii) Any fees collected thereafter shall be
- 17 deposited [in] <u>into</u> the General Fund.
- 18 (2) For the fiscal year 2003-2004 and beyond, [all fees
- 19 collected] that portion of the fee representing \$5 per ton
- 20 <u>shall be deposited into the General Fund and the balance of</u>
- 21 <u>the fee</u> shall be deposited into the Environmental Stewardship
- Fund established in Chapter 61.
- 23 Section 2. This act shall take effect in 60 days.
