- 11 "Common interest community." Includes a cooperative, a
- 12 condominium and a planned community where an individual, by
- 13 virtue of an ownership interest in any portion of real estate,
- 14 is or may become obligated by covenant, easement or agreement
- 15 imposed upon the owner's interest to pay any amount for real
- 16 property taxes, insurance, maintenance, repair, improvement,

- 1 management, administration or regulation of any part of the real
- 2 <u>estate other than the portion or interest owned solely by the</u>
- 3 <u>individual</u>.
