2 "An act establishing a uniform construction code; imposing
3 powers and duties on municipalities and the Department of
4 Labor and Industry; providing for enforcement; imposing
5 penalties; and making repeals," ~~creating~~ FURTHER PROVIDING <—

7 RELATING TO STATE-OWNED BUILDINGS; AND ESTABLISHING the

14 SECTION 1. SECTION 105(B) OF THE ACT OF NOVEMBER 10, 1999 <—
15 (P.L.491, NO.45), KNOWN AS THE PENNSYLVANIA CONSTRUCTION CODE
16 ACT, IS AMENDED BY ADDING A PARAGRAPH TO READ:

2 (5) THE DEPARTMENT MAY ENTER INTO CONTRACTS WITH
3 MUNICIPALITIES, COUNCILS OF GOVERNMENTS, CONSTRUCTION CODE
4 OFFICIALS AND THIRD-PARTY AGENCIES FOR THE ADMINISTRATION AND
5 ENFORCEMENT OF THIS ACT FOR STATE-OWNED BUILDINGS INCLUDING A
6 STATE-AFFILIATED ENTITY OR STATE-RELATED INSTITUTION AS
7 DEFINED IN 62 PA.C.S. § 103 (RELATING TO DEFINITIONS).

9 SECTION 2. THE ACT IS AMENDED BY ADDING A SECTION TO READ:

11 (a) Establishment.--There is established in the State
12 Treasury a nonlapsing restricted receipt account to be known as
13 the Uniform Construction Fund for the deposit of all fees
14 ~~authorized by this chapter.~~ LEVIED AND COLLECTED BY THE
15 DEPARTMENT AS AUTHORIZED BY THIS ACT AND THE REGULATIONS.

16 (b) Distribution of funds.--All money deposited in the THIS
17 account and any investment income accrued are appropriated
18 annually to the Department of Labor and Industry. for the
19 ~~purposes of this act.~~

20 (c) Purpose.--The department shall utilize the fund to
21 administer this act.

22 Section ~~2~~ 3. This act shall take effect in 60 days.
