## A RESOLUTION

- 1 Designating the month of March 2003 as "Professional Social 2 Workers Month" in Pennsylvania.
- 3 WHEREAS, The Pennsylvania Chapter of the National Association
- 4 of Social Workers educates Pennsylvania's citizens and elected
- 5 officials regarding the services social workers provide in this
- 6 Commonwealth; and
- 7 WHEREAS, Social workers assist thousands of Pennsylvanians
- 8 with social and psychological problems; and
- 9 WHEREAS, Social workers empower individuals who are
- 10 frequently unheard; and
- 11 WHEREAS, Social workers are dedicated advocates for the
- 12 rights of others; and

- 1 WHEREAS, Social workers help people overcome adversities and
- 2 contribute to the well-being of society; and
- 3 WHEREAS, Social workers open the doors of access and
- 4 opportunity for everyone, particularly those in greatest need;

- 6 WHEREAS, Social workers use their education, professional
- 7 training and commitment to improve the lives of individuals,
- 8 families and communities in this Commonwealth; and
- 9 WHEREAS, Social workers shape numerous programs and policies
- 10 that strengthen individual lives, society and community life;

- 12 WHEREAS, Social workers, whether in direct practice,
- 13 administration, education and research or policy development,
- 14 impact every community in this Commonwealth; and
- WHEREAS, Social workers provide services in many settings,
- 16 including private practices, family counseling centers, courts,
- 17 nursing homes, hospices, schools and universities, prisons,
- 18 corporations and public and private agencies; therefore be it
- 19 RESOLVED, That the House of Representatives designate the
- 20 month of March 2003 as "Professional Social Workers Month" in
- 21 Pennsylvania; and be it further
- 22 RESOLVED, That the House of Representatives call on all
- 23 citizens to join with the National Association of Social Workers
- 24 and the Pennsylvania Chapter of the National Association of
- 25 Social Workers to recognize, celebrate and support the
- 26 commitment and dedication of social workers and the social work
- 27 profession in this Commonwealth.
