11	Section 1. Section 501(a) and (c) of Title 22 of the
12	Pennsylvania Consolidated Statutes are amended to read:
13	§ 501. Appointment by nonprofit corporations.
14	(a) Appointment authorized Any nonprofit corporation, as
15	defined in 15 Pa.C.S. Pt. II Subpt. C (relating to nonprofit
16	corporations) maintaining a cemetery or any buildings or grounds
17	open to the public, or organized for the prevention of cruelty
18	to children or aged persons [or animals], or one or more of such
19	purposes, may apply to the court of common pleas of the county

- 1 of the registered office of the corporation for the appointment
- 2 of such persons as the corporation may designate to act as
- 3 policemen for the corporation. The court, upon such application,
- 4 may by order appoint such persons, or as many of them as it may
- 5 deem proper and necessary, to be such policemen.
- 6 * * *
- 7 (c) Powers.--Such policemen, so appointed, shall severally
- 8 possess and exercise all the powers of a police officer in this
- 9 Commonwealth, in and upon, and in the immediate and adjacent
- 10 vicinity of, the property of the corporation. Policemen so
- 11 appointed for a corporation organized for the prevention of
- 12 cruelty to children or aged persons [or animals], or one or more
- 13 of such purposes, shall severally possess and exercise all the
- 14 powers of a police officer in any county in which they may be
- 15 directed by the corporation to act, and are hereby authorized to
- 16 arrest persons for the commission of any offense of cruelty to
- 17 children or aged persons [or animals]. The keepers of jails and
- 18 other places of detention in any county of this Commonwealth
- 19 shall receive all persons arrested by such policemen for
- 20 purposes of detention until they are dealt with according to
- 21 law. Every policeman appointed under this section, when on duty,
- 22 shall wear a metallic shield with the words "special officer"
- 23 and the name of the corporation for which appointed inscribed
- 24 thereon.

- 7 This chapter deals with humane society police officers.
- 8 § 3702. Definitions.
- 9 The following words and phrases when used in this chapter
- 10 shall have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Account." The Humane Society Police Officer Account
- 13 established in section 3717 3716 (relating to Humane Society <
- 14 Police Officer Account).
- 15 "Agricultural animal." Any bovine animal, equine animal,
- 16 sheep, goat, pig, poultry, bird, fowl, wild or semiwild animal
- 17 or fish or other aquatic animal that is being raised, kept,
- 18 transported or utilized for the purpose of or pursuant to
- 19 agricultural production.
- 20 "Agricultural production." The production and preparation
- 21 for market of agricultural animals and their products and of
- 22 agricultural, agronomic, horticultural, silvicultural and
- 23 aquacultural crops and commodities.
- 24 "Board." The Humane Society Police Officer Advisory Board.
- 25 "Complainant." Any person who has evidence that an
- 26 individual appointed as a humane society police officer has
- 27 performed in a manner that is contrary to the standards,
- 28 requirements and qualifications prescribed in this chapter for
- 29 appointment of individuals as humane society police officers.
- 30 The term also includes a district attorney or a municipal

- 1 solicitor.
- 2 "Convicted." A finding or verdict of guilt, an admission of
- 3 guilt or a plea of nolo contendere or receiving probation
- 4 without verdict, disposition in lieu of trial or an Accelerated
- 5 Rehabilitative Disposition in the disposition of felony charges.
- 6 "Cruelty to animals laws." The provisions of 18 Pa.C.S. §
- 7 5511 (relating to cruelty to animals).
- 8 "Department." The Department of Agriculture of the
- 9 Commonwealth.
- 10 "Humane society police officer." Any person who holds a
- 11 current appointment under this chapter to act as a humane
- 12 society police officer for a society or association for the
- 13 prevention of cruelty to animals. The term shall include an
- 14 individual who is an agent of a society or association for the
- 15 prevention of cruelty to animals as "agent" is used in 18
- 16 Pa.C.S. § 5511 (relating to cruelty to animals) provided that
- 17 individual holds a current appointment under this chapter.
- 18 "Secretary." The Secretary of Agriculture of the
- 19 Commonwealth.
- 20 "Serious misdemeanor." A criminal offense for which more
- 21 than one year in prison can be imposed as a punishment.
- 22 "Society or association." A nonprofit society or association
- 23 duly incorporated pursuant to 15 Pa.C.S. Ch. 53 Subch. A
- 24 (relating to incorporation generally) for the purpose of the
- 25 prevention of cruelty to animals.
- 26 § 3703. Appointment required.
- 27 It shall be unlawful for any individual to hold himself forth
- 28 as a humane society police officer unless the individual has
- 29 obtained an appointment pursuant to this chapter.
- 30 § 3704. Appointment by nonprofit corporations.

- 1 (a) Application for appointment. -- A society or association
- 2 may apply to the court of common pleas in a ANY county for the <--
- 3 appointment of an individual as a humane society police officer
- 4 for that county. The court, upon such application WHICH INCLUDES <-
- 5 PROOF OF QUALIFICATION UNDER SECTION 3705 (RELATING TO
- 6 QUALIFICATIONS FOR APPOINTMENT), shall by order appoint such
- 7 person to be a humane society police officer.
- 8 (b) Oath.--Every individual appointed as a humane society
- 9 police officer pursuant to this chapter shall, before entering
- 10 upon the duties of the office, take and subscribe to the oath
- 11 required by Article VI of the Constitution of Pennsylvania.
- 12 § 3705. Qualifications for appointment.
- 13 An individual shall be qualified for an appointment as a
- 14 humane society police officer provided the society or
- 15 association submits proof satisfactory to the court of common
- 16 pleas in each county for which the society or association
- 17 directs the individual to act as a humane society police officer
- 18 that the individual meets all of the following requirements:
- 19 (1) Has been a resident of this Commonwealth for the
- 20 previous 12 months.
- 21 (2) Has successfully completed the training program
- 22 established pursuant to section 3713 3712 (relating to
- training program).
- 24 (3) Has obtained a criminal history report from the
- Pennsylvania State Police pursuant to 18 Pa.C.S. Ch. 91
- 26 (relating to criminal history record information) or a
- 27 statement from the Pennsylvania State Police that the
- 28 Pennsylvania State Police central repository contains no
- 29 pertinent information relating to the individual who is the
- 30 subject of the application. The criminal history record

- 1 information shall be limited to that which may be
- disseminated pursuant to 18 Pa.C.S. § 9121(b)(2) (relating to
- 3 general regulations).
- 4 (4) Has not been convicted of an offense graded a felony
- 5 or a serious misdemeanor.
- 6 (5) Has not been convicted of any violation, including a
- 7 summary offense, of 18 Pa.C.S. § 5511 (relating to cruelty to
- 8 animals).
- 9 (6) Has not been convicted of an offense in another
- jurisdiction, state, territory or country in accordance with
- 11 the laws of that jurisdiction, state, territory or country
- 12 equivalent to an offense graded a felony or a serious
- misdemeanor or an offense of cruelty to animals.
- 14 § 3706. Temporary appointment.
- 15 (a) Qualifications. A society or association may petition a

- 16 court of common pleas in a county for temporary appointment of
- 17 an individual as a humane society police officer in that county,
- 18 provided that no other individual is currently appointed to act
- 19 as a humane society police officer from the society or
- 20 association and the individual meets all of the following
- 21 requirements:
- 22 (1) Has been a resident of this Commonwealth for the
- 23 previous 12 months.
- 24 (2) Holds a current appointment granted under this
- 25 chapter in another county located within this Commonwealth.
- 26 (3) Has obtained a criminal history report from the
- 27 Pennsylvania State Police pursuant to 18 Pa.C.S. Ch. 91
- 28 (relating to criminal history record information) or a
- 29 statement from the Pennsylvania State Police that the
- 30 Pennsylvania State Police central repository contains no

- 1 pertinent information relating to the individual who is the
- 2 subject of the application. The criminal history record
- 3 information shall be limited to that which may be
- 4 disseminated pursuant to 18 Pa.C.S. § 9121(b)(2) (relating to
- 5 general regulations).
- 6 (4) Has not been convicted of an offense graded a felony
- 7 or a serious misdemeanor.
- 8 (5) Has not been convicted of any violation, including a
- 9 summary offense, of 18 Pa.C.S. § 5511 (relating to cruelty to
- 10 animals).
- 11 (6) Has not been convicted of an offense in another
- 12 jurisdiction, state, territory or country in accordance with
- the laws of that jurisdiction, state, territory or country
- 14 equivalent to an offense graded a felony or a serious
- 15 misdemeanor or an offense of cruelty to animals.
- 16 (b) Term. A temporary appointment under this section shall
- 17 expire at the end of six months or such time as the temporarily
- 18 appointed individual or any other individual is permanently
- 19 appointed by the court of common pleas to act as a humane
- 20 society police officer in the county, whichever is sooner. No
- 21 more than one temporary appointment shall be effective for any
- 22 society or association at any time.
- 23 § 3707 3706. Suspension, revocation, limitation and restriction
- of appointment; restoration of appointment.
- 25 (a) Grounds for suspension, revocation, limitation or
- 26 restriction. -- By its own action or pursuant to a written
- 27 affidavit filed by a complainant, the court of common pleas may,
- 28 after conducting a hearing, suspend, revoke, limit or restrict
- 29 an appointment of an individual to act as a humane society
- 30 police officer in the county if the court determines any of the

- 1 following:
- 2 (1) Being convicted of a felony or a serious misdemeanor
- 3 in any Federal or State court or being convicted of the
- 4 equivalent of a felony in any foreign country, territory or
- 5 possession.
- 6 (2) Being convicted of an offense of cruelty to animals
- 7 in any Federal or State court or being convicted of the
- 8 equivalent of a cruelty to animals offense in any foreign
- 9 country, territory or possession.
- 10 (3) Presenting false credentials or documents or making
- a false or misleading statement in the application for
- appointment or a certification of completion of additional
- training or submitting an application for appointment or a
- 14 certification for completion of additional training
- 15 containing a false or misleading statement.
- 16 (4) Carrying or possessing a firearm in the performance
- of his or her duties without certification pursuant to
- section 3712 3711 (relating to limitation on possession of
- 19 firearms).
- 20 (5) The individual has conducted his or her authority to

- 21 enforce animal cruelty laws in a manner that is substandard
- 22 of conduct normally expected of humane society police
- 23 officers.
- 24 (b) Notice to department. -- Upon action by the court of
- 25 common pleas to refuse, suspend, revoke, limit or restrict an
- 26 appointment, the clerk of courts of the county shall forward
- 27 such information to the department for the purpose of the
- 28 Statewide registry established pursuant to section 3715 3714
- 29 (relating to Statewide registry).
- 30 (c) Restoration.--The court of common pleas may restore a

- 1 suspended appointment of an individual if the individual
- 2 provides to the court evidence sufficient to warrant restoration
- 3 and the court determines the grounds for suspension have been
- 4 satisfactorily corrected and the individual otherwise qualifies
- 5 for appointment. In restoring the appointment, the court may
- 6 continue to impose limitations and corrective measures the court
- 7 determines to be necessary to ensure an individual's compliance
- 8 with the requirements of this chapter.
- 9 § 3708 3707. Termination of appointment.
- 10 (a) General rule.--All powers and authority granted to an
- 11 individual under section 3709 3708 (relating to powers and
- 12 authority; jurisdiction) shall immediately terminate upon notice
- 13 to the individual from the society or association for which
- 14 appointed that services are no longer required of the
- 15 individual.
- 16 (b) Notice to court. -- The society or association must file
- 17 notice within ten days of a termination of an individual as a
- 18 humane society police officer with the clerk of courts in each
- 19 county in which the individual has been appointed as a humane
- 20 society police officer.
- 21 (c) Notice to department. -- The society or association must
- 22 file notice within ten days of a termination of an individual as
- 23 a humane society police officer with the department for the
- 24 purpose of providing information relevant to the Statewide
- 25 registry established pursuant to section 3715 3714 (relating to
- 26 Statewide registry).
- 27 § 3709 3708. Powers and authority; jurisdiction.
- 28 (a) Authority limited to county of appointment. -- An
- 29 individual appointed as a humane society police officer in
- 30 accordance with this chapter shall have power and authority to

- 1 exercise the powers conferred under 18 Pa.C.S. § 5511 (relating
- 2 to cruelty to animals) in enforcement of animal cruelty laws
- 3 only within the particular county whose court of common pleas
- 4 issued the appointment. The individual has no power or authority
- 5 to exercise the powers conferred under 18 Pa.C.S. § 5511 in any
- 6 other county whose court of common pleas has not issued an
- 7 appointment.
- 8 (b) Notice to district attorney.--Prior to exercising the
- 9 power and authority set forth by this chapter within a county,
- 10 each appointed humane society police officer shall file notice
- 11 along with a copy of the appointment granted under this chapter
- 12 with the district attorney of the county.
- 13 (c) Shield.--Every individual appointed as a humane society
- 14 police officer under this chapter shall possess a metallic
- 15 shield with the words "humane society police officer" and the
- 16 name of the society or association for which the individual is
- 17 appointed displayed thereon.
- 18 (d) Photo identification. -- Every individual appointed as a
- 19 humane society police officer under this chapter shall have a
- 20 photo identification card issued by the department that contains
- 21 the following:
- 22 (1) A photo of the individual taken within the previous
- 23 24 months.
- 24 (2) The name of the individual.
- 25 (3) The signature of the individual.
- 26 (4) The name of the society or association for which the
- 27 individual is appointed as a humane society police officer.
- 28 (5) The address and telephone number of the society or
- association for which the individual is appointed as a humane
- 30 society police officer.

- 1 (6) The date of issuance of the photo identification
- 2 card.
- 3 § 3710 3709. Penalties.
- 4 (a) Criminal penalties. -- A person who violates this chapter

- 5 commits a misdemeanor of the third degree and shall, upon
- 6 conviction, be sentenced to pay a fine of up to \$1,000 or to
- 7 imprisonment for not more than 90 days, or both.
- 8 (b) Civil penalties.--In addition to any criminal penalties
- 9 or other civil remedy, a person, association or society who
- 10 violates this chapter may be subject to a civil penalty of up to
- 11 \$1,000.
- 12 (c) Disposition. All fines and civil penalties imposed in
- 13 accordance with this section shall be paid into the account.
- 14 § 3711 3710. Search warrants.
- 15 Notwithstanding contrary provisions of 18 Pa.C.S. § 5511(1)
- 16 (relating to cruelty to animals) and in addition to the
- 17 requirements of existing law, all search warrant applications
- 18 filed in connection with alleged violations of cruelty to
- 19 animals laws must have the approval of the district attorney in
- 20 the county of the alleged offense prior to filing.
- 21 § 3712 3711. Limitation on possession of firearms.
- 22 No individual appointed as a humane society police officer
- 23 shall carry, possess or use a firearm in the performance of that
- 24 individual's duties unless that individual holds a current and
- 25 valid certification in the use and handling of firearms pursuant
- 26 to at least one of the following:
- 27 (1) 53 Pa.C.S. Ch 21 Subch. D (relating to municipal
- 28 police education and training).
- 29 (2) The act of October 10, 1974 (P.L.705, No.235), known
- 30 as the Lethal Weapons Training Act.

- 1 (3) The act of February 9, 1984 (P.L.3, No.2), known as
- the Deputy Sheriffs' Education and Training Act.
- 3 (4) Any other firearms program that has been determined
- 4 by the Commissioner of the Pennsylvania State Police to be of

- 5 sufficient scope and duration as to provide the participant
- 6 with basic training in the use and handling of firearms.
- 7 § 3713 3712. Training program.
- 8 (a) Required training.--Every individual, prior to the
- 9 society or association making application for appointment as a
- 10 humane society police officer, shall successfully complete the
- 11 minimum requirements for initial training prescribed in the
- 12 program for initial training of humane society police officers
- 13 established in accordance with subsections (b), (c), (d) and
- 14 (e).
- 15 (b) Contracts.--The secretary, with the advice of the board,
- 16 shall contract with an accredited college or university,
- 17 including a community college or other public or private entity
- 18 for the establishment of a program for the training of
- 19 individuals to act as humane society police officers. The
- 20 contracted entity shall forward information pertaining to an
- 21 individual's successful completion of the initial training
- 22 program to the department for the purpose of maintaining the
- 23 Statewide registry established pursuant to section 3715 3714
- 24 (relating to Statewide registry).
- 25 (c) Minimum requirements. -- The program for the training of
- 26 humane society police officers shall include, at a minimum, 60
- 27 hours of instruction in accordance with subsection (d).
- 28 (d) Curriculum. -- The program for the training of humane
- 29 society police officers shall provide instruction in the
- 30 following instructional areas:

1 (1) At least 36 hours of instruction shall be provided on the following: 2 3 (i) Pennsylvania cruelty to animal laws. (ii) Pennsylvania Rules of Criminal Procedure. 4 (iii) Care and treatment of animals. 5 (iv) Proper execution of search warrants. 6 (v) Proper search and seizure practices. 7 (vi) Any other areas relating to law enforcement 8 duties. 9 (2) At least 24 hours of instruction shall be provided 10 11 on the following: (i) Animal husbandry practices constituting normal 12 13 agricultural operation. 14 (ii) Practices accepted in the agricultural industry 15 in the raising, keeping and production of agricultural animals. 16 17 (iii) Characteristics of agricultural animals likely 18 evidencing care that is in violation of the cruelty to animal laws. 19 20 (iv) Proper care and handling of agricultural animals pursuant to enforcement of the cruelty to animals 21 22 laws. 23 (v) Treatments administered and research conducted during the normal scope of veterinarian practices. 24 25 (e) Final examination. -- The training program shall require 26 individuals, as a prerequisite to successful completion of the 27 program, to take and pass a final examination that sufficiently measures the individuals's knowledge and understanding of the 28 instructional material. 29 30 (f) Current officers.--Individuals who have been appointed

- 10 (a) Required training.--During each two-year period
- 11 following the date in which an individual has been initially
- 12 appointed as a humane society police officer, the individual
- 13 shall successfully complete the minimum requirements for
- 14 additional training prescribed in the program for continuous
- 15 education of humane society police officers established in
- 16 accordance with subsections (b), (c), (d) and (e).
- 17 (b) Contracts.--The secretary, with the advice of the board,
- 18 shall contract with an accredited college or university,
- 19 including a community college, or other public or private entity
- 20 for the establishment of a continuing education program for the
- 21 training of individuals to act as humane society police
- 22 officers. The contracted entity shall forward information
- 23 pertaining to an individual's successful completion of the

- 6 (a) Establishment.--There is hereby established a Statewide
- 7 registry within the department for the purpose of maintaining
- 8 information relating to individuals appointed as humane society
- 9 police officers.
- 10 (b) Access to registry. -- The information included within the
- 11 Statewide registry shall be made accessible to the public
- 12 through the department's World Wide Web site and shall include
- 13 the following:
- 14 (1) The name of each individual appointed as a humane
- 15 society police officer.
- 16 (2) The name and address of the society or association
- for which each individual is appointed as a humane society
- 18 police officer.
- 19 (3) The counties in which the individual has been
- 20 appointed as a humane society police officer and dates of
- 21 appointment.
- 22 (4) The counties in which the individual has had an
- 23 appointment revoked, suspended, limited or restricted, the
