1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
2 Statutes, further providing for unattended children in motor
3 ~~vehicles, for fleeing or attempting to elude police officer~~ <—
4 ~~and for restrictions on highway and bridge use.~~ VEHICLES AND <—
5 FOR FLEEING OR ATTEMPTING TO ELUDE POLICE OFFICER.

6 The General Assembly of the Commonwealth of Pennsylvania
7 hereby enacts as follows:

8 Section 1. Section 3701.1(b) of Title 75 of the Pennsylvania
9 Consolidated Statutes is amended to read:

10 § 3701.1. Leaving an unattended child in a motor vehicle.

12 (b) Penalty.--A person who violates this section commits a
13 summary offense. It is a separate offense for each child left
14 unattended.

15 Section 2. Section 3733(a) of Title 75 is amended and the
16 section is amended by adding a subsection to read:

17 § 3733. Fleeing or attempting to elude police officer.

1 (a) Offense defined.--Any driver of a motor vehicle who
2 willfully fails or refuses to bring his vehicle to a stop, or
3 who otherwise flees or attempts to elude a pursuing police
4 officer, when given visual or audible signal to bring the
5 vehicle to a stop, commits [a misdemeanor of the second degree.
6 Any driver upon conviction shall pay an additional fine of \$500.
7 This fine shall be in addition to and not in lieu of all other
8 fines, court expenses, jail sentences or penalties] an offense
9 as graded in subsection (a.2).

11 (a.2) Grading.--

12 (1) Except as provided in paragraph (2), an offense
13 under subsection (a) constitutes a misdemeanor of the second
14 degree. Any driver upon conviction shall pay an additional
15 fine of \$500. This fine shall be in addition to and not in
16 lieu of all other fines, court expenses, jail sentences or
17 penalties.

18 (2) An offense under subsection (a) constitutes a felony
19 of the third degree if the driver, simultaneously:

20 (i) commits a violation of section 3802 (relating to
21 driving under influence of alcohol or controlled
22 substance); or

23 (ii) crosses a State line.
