- l Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- Statutes, providing for a special license plate for
- 3 recipients of the Silver Star and Bronze Star.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Title 75 of the Pennsylvania Consolidated
- 7 Statutes is amended by adding sections to read:
- 8 <u>§ 1362. Special plates for recipients of Silver Star.</u>
- 9 Upon application of any person who is a recipient of the
- 10 Silver Star, accompanied by a fee of \$20 \$10 which shall be in
- 11 addition to the annual registration fee and by such
- 12 documentation as the department shall require by regulation, the
- 13 department shall issue to the person a special registration
- 14 plate designating the vehicle so licensed as belonging to a

- 1 person who is a recipient of the Silver Star. The special
- 2 registration plate may be used only on one passenger vehicle A <-
- 3 PASSENGER CAR or one other vehicle TRUCK with a registered gross <--
- 4 weight of not more than 9,000 10,000 pounds.
- 5 § 1363. Special plates for recipient of Bronze Star.
- 6 Upon application of any person who is a recipient of the
- 7 Bronze Star, accompanied by a fee of \$20 which shall be in
- 8 addition to the annual registration fee and by such
- 9 documentation as the department shall require by regulation, the
- 10 <u>department shall issue to the person a special registration</u>
- 11 plate designating the vehicle so licensed as belonging to a
- 12 person who is a recipient of the Bronze Star. The special
- 13 registration plate may be used only on one passenger vehicle A <-
- 14 PASSENGER CAR or one other vehicle TRUCK with a registered gross <-
- 15 weight of not more than 9,000 10,000 pounds.
- 16 § 1364. SPECIAL PLATES FOR RECIPIENT OF BRONZE STAR FOR VALOR. <---
- 17 UPON APPLICATION OF ANY PERSON WHO IS A RECIPIENT OF THE
- 18 BRONZE STAR FOR VALOR, ACCOMPANIED BY A FEE OF \$10 WHICH SHALL
- 19 BE IN ADDITION TO THE ANNUAL REGISTRATION FEE AND BY SUCH
- 20 DOCUMENTATION AS THE DEPARTMENT SHALL REQUIRE BY REGULATION, THE
- 21 DEPARTMENT SHALL ISSUE TO THE PERSON A SPECIAL REGISTRATION
- 22 PLATE DESIGNATING THE VEHICLE SO LICENSED AS BELONGING TO A
- 23 PERSON WHO IS A RECIPIENT OF THE BRONZE STAR FOR VALOR. THE
- 24 SPECIAL REGISTRATION PLATE MAY BE USED ONLY ON A PASSENGER CAR
- 25 OR TRUCK WITH A REGISTERED GROSS WEIGHT OF NOT MORE THAN 10,000
- 26 POUNDS.
- 27 Section 2. This act shall take effect in 60 days.
