AN ACT

- 1 Establishing an emergency uniform numbering system for public schools.
- 3 The General Assembly finds and declares as follows:
- 4 (1) Extreme dangers are present when the safety of our
- 5 students in public schools requires first responders such as
- 6 police and firefighters to evacuate and secure a building.
- 7 (2) In an effort to prepare for responding to
- 8 emergencies, criminal acts and acts of terrorism a public
- 9 school uniform emergency numbering system is needed to
- 10 provide all first responders with the information they need
- to be successful when handling an emergency.
- 12 The General Assembly of the Commonwealth of Pennsylvania
- 13 hereby enacts as follows:
- 14 Section 1. Short title.
- This act shall be known and may be cited as the Public School
- 16 Emergency Numbering System Act.
- 17 Section 2. Definitions.

- 1 The following words and phrases when used in this act shall
- 2 have the meanings given to them in this section unless the
- 3 context clearly indicates otherwise:
- 4 "Agency." Pennsylvania Emergency Management Agency.
- 5 "Emergency service responders." The term includes volunteer
- 6 and municipal fire companies, law enforcement agencies, control
- 7 offices, ambulance and medical services that provide for the
- 8 protection or preservation of persons or property in
- 9 circumstances of immediate and significant threat of injury or
- 10 harm.
- 11 "Public school." Any school in this Commonwealth that is in
- 12 a public school district as defined in the act of March 10, 1949
- 13 (P.L.30, No.14), known as the Public School Code of 1949.
- "Specialty rooms." The term includes, but is not limited to,
- 15 boiler rooms, electrical rooms, storage rooms and utility rooms.
- 16 "Uniform numbering system." A Statewide standardized room
- 17 identification plan for public schools.
- 18 Section 3. Emergency uniform numbering system.
- 19 (a) Establishment.--The agency, in consultation with
- 20 emergency service responders, shall establish a Statewide public
- 21 school uniform numbering system. The uniform numbering system
- 22 shall address the following, but not be limited to:
- 23 (1) The size, location, florescence, heat resistance of
- the room number/letter that identifies one room from another
- room. A public school shall place a room number at both floor
- level and eye level.
- 27 (2) Appropriately labeled rooms that may contain
- dangerous materials and a uniform system for labeling rooms,
- 29 hallways and outside doors.
- 30 (3) Establishment of school building sections based on a

- 1 grid structure.
- 2 (b) Regulations and procedures. -- The agency shall adopt
- 3 regulations and procedures necessary for public schools to
- 4 implement the system.
- 5 Section 4. Implementation.
- 6 (a) Submission. -- The agency shall submit the adopted
- 7 regulations and procedures to the emergency service responders
- 8 and public schools for implementation.
- 9 (b) Time limits.--The public schools shall have no less than
- 10 six months but no more than one year to implement the agency
- 11 regulations.
- 12 Section 5. Effective date.
- 13 This act shall take effect immediately.
