AN ACT

1 Amending Titles 42 (Judiciary and Judicial Procedure) and 44
2 (Law and Justice) of the Pennsylvania Consolidated Statutes,
3 further providing for registration and for the definition of
4 "other specified offense."

5 The General Assembly of the Commonwealth of Pennsylvania
6 hereby enacts as follows:

7 Section 1. Section 9795.1(a)(2) of Title 42 of the
8 Pennsylvania Consolidated Statutes is amended to read:

9 § 9795.1. Registration.

10 (a) Ten-year registration.--The following individuals shall
11 be required to register with the Pennsylvania State Police for a
12 period of ten years:

13 * * *

14 (2) Individuals convicted of an attempt, conspiracy or
15 solicitation to commit any of the offenses under paragraph

1 (1) or subsection (b)(2).

3 Section 2. The definition of "other specified offense" in
4 section 2303 of Title 44 is amended to read:

5 § 2303. Definitions.

6 The following words and phrases when used in this chapter
7 shall have the meanings given to them in this section unless the
8 context clearly indicates otherwise:

9 * * *

10 "Other specified offense." A felony offense or an offense
11 under 18 Pa.C.S. § 2910 (relating to luring a child into a motor
12 vehicle) or 3126 (relating to indecent assault) or an attempt,
13 conspiracy or solicitation to commit such an offense.

14 * * *

15 Section 3. This act shall take effect in 60 days.
