- 1 Upon application of any person who is a recipient of the
- 2 Medal of Honor, <u>Distinguished Service Cross</u>, <u>Distinguished</u>
- 3 Flying Cross, Navy Cross, Air Force Cross or Silver Star, OR AIR <-
- 4 FORCE CROSS, the department shall issue to such person a special
- 5 registration plate designating the vehicle so licensed as
- 6 belonging to a person who is a recipient of the Medal of Honor,
- 7 <u>Distinguished Service Cross, Distinguished Flying Cross, Navy</u>
- 8 Cross OR Air Force Cross or Silver Star. THE SPECIAL
- 9 REGISTRATION PLATE MAY BE USED ONLY ON A PASSENGER CAR OR TRUCK
- 10 WITH A REGISTERED GROSS WEIGHT OF NOT MORE THAN 10,000 POUNDS.
- 11 The plate shall have a light blue background interspersed with
- 12 <u>13 white stars. The center of the plate shall bear a golden</u>
- 13 bronze replica of the appropriate medal. The initials of each
- 14 recipient shall be embossed in red to the left of the medal and
- 15 the letters "CMH" (for Congressional Medal of Honor), "DSC" (for
- 16 Distinguished Service Cross), "DFS" (for Distinguished Flying
- 17 Cross), "NC" (for Navy Cross), "AFC" (for Air Force Cross) or
- 18 "SS" (for Silver Star) CROSS) OR "AFC" (FOR AIR FORCE CROSS)
- 19 shall be embossed in red to the right of the medal.
