AN ACT

Amending the act of January 24, 1966 (1965 P.L.1535, No.537), 2 entitled, as amended, "An act providing for the planning and 3 regulation of community sewage systems and individual sewage systems; requiring municipalities to submit plans for systems 5 in their jurisdiction; authorizing grants; requiring permits for persons installing such systems; requiring disclosure 7 statements in certain land sale contracts; authorizing the Department of Environmental Resources to adopt and administer 8 rules, regulations, standards and procedures; creating an 9 10 advisory committee; providing remedies and prescribing penalties," further providing for penalties and for fines, civil penalties and fees; and making editorial changes. 11 12 13 The General Assembly of the Commonwealth of Pennsylvania 14 hereby enacts as follows: 15 Section 1. The definitions of "delegated agency," "department," "official plan" and "secretary" in section 2 of 16 the act of January 24, 1966 (1965 P.L.1535, No.537), known as 17 18 the Pennsylvania Sewage Facilities Act, amended December 14, 19 1994 (P.L.1250, No.149), are amended to read: 20 Section 2. Definitions. -- As used in this act: 21

- 1 "Delegated agency" means a municipality, local agency,
- 2 multimunicipal local agency or county or joint county department
- 3 of health to which the Department of Environmental [Resources]
- 4 Protection has delegated the authority to review and approve
- 5 subdivisions for new land developments as supplements to the
- 6 official plan of a municipality in which the subdivision is
- 7 located.
- 8 "Department" means the Department of Environmental
- 9 [Resources] Protection of the Commonwealth [of Pennsylvania].

- "Official plan" means a comprehensive plan for the provision
- 12 of adequate sewage systems adopted by a municipality or
- 13 municipalities possessing authority or jurisdiction over the
- 14 provision of such systems and submitted to and approved by the
- 15 State Department of Environmental [Resources] Protection as
- 16 provided herein.

- "Secretary" means the Secretary of Environmental [Resources]
- 19 Protection of the Commonwealth [of Pennsylvania].

- 21 Section 2. Section 13 of the act, amended December 14, 1994
- 22 (P.L.1250, No.149), is amended to read:
- 23 Section 13. Penalties.--[Any] (a) Except as otherwise
- 24 provided under subsection (b), any person who shall violate any
- 25 provision of this act or the rules, regulations or standards
- 26 promulgated pursuant to this act or who is the owner of a
- 27 property on which a condition exists which constitutes a
- 28 nuisance under this act or who resists or interferes with any
- 29 officer, agent or employe of a local agency or the department,
- 30 in accordance with the provisions of this act, in the

- 1 performance of his duties, shall be guilty of a summary offense.
- 2 Upon conviction thereof, such person shall be sentenced to pay a
- 3 fine of not less than five hundred dollars (\$500) nor more than
- 4 five thousand dollars (\$5,000), plus costs, or to imprisonment
- 5 not to exceed ninety days, or both.
- 6 (b) This section shall apply to a sewage enforcement officer
- 7 only when that officer is the owner of the property on which a
- 8 condition exists which constitutes a nuisance under this act.
- 9 Any action taken by the department against a sewage enforcement
- 10 officer under this act must be initiated with the State Board
- 11 <u>for Certification of Sewage Enforcement Officers and the</u>
- 12 <u>department shall have the burden of proving the violation.</u>
- 13 Section 3. Section 13.1 of the act is amended by adding a
- 14 subsection to read:
- 15 Section 13.1. Fines, Civil Penalties and Fees. -- * * *
- 16 (a.1) Subsection (a) shall apply to a sewage enforcement
- 17 officer only when that officer is the owner of the property on
- 18 which a condition exists which constitutes a nuisance under this
- 19 act. Any action taken by the department against a sewage
- 20 <u>enforcement officer under this act must be initiated with the</u>
- 21 State Board for Certification of Sewage Enforcement Officers and
- 22 the department shall have the burden of proving the violation.

- 24 Section 4. This act shall take effect in 60 days.
