AN ACT

- 1 Requiring a circulating nurse in certain operating rooms.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Short title.
- 5 This act shall be known and may be cited as the Circulating
- 6 Nurse Act.
- 7 Section 2. Purpose.
- 8 The purpose of this legislation is to require a registered
- 9 nurse to be the circulating nurse in an operating room for the
- 10 safety of the patient.
- 11 Section 3. Definitions.
- 12 The following words and phrases when used in this act shall
- 13 have the meanings given to them in this section unless the
- 14 context clearly indicates otherwise:
- 15 "Conscious sedation." A minimally depressed level of
- 16 consciousness which retains the patient's ability to

- 1 independently and continuously maintain an airway and respond
- 2 appropriately to physical stimulation or verbal command,
- 3 produced by a pharmacologic or nonpharmacologic method, or
- 4 combination thereof.
- 5 "General anesthesia." A controlled state of unconsciousness,
- 6 including deep sedation, accompanied by the partial or complete
- 7 loss of protective reflexes which includes the patient's
- 8 inability to independently maintain an airway and respond
- 9 purposefully to physical stimulation or verbal command, produced
- 10 by a pharmacologic or nonpharmacologic method, or combination
- 11 thereof.
- 12 "Health care facility." Any health care facility providing
- 13 clinically related health services, including, but not limited
- 14 to, a general or special hospital, including psychiatric
- 15 hospitals, rehabilitation hospitals, ambulatory surgical
- 16 facilities, long-term care nursing facilities, cancer treatment
- 17 centers using radiation therapy on an ambulatory basis and
- 18 inpatient drug and alcohol treatment facilities, both profit and
- 19 nonprofit, and including those operated by an agency or State or
- 20 local government. The term shall also include a hospice. The
- 21 term shall not include an office used primarily for the private
- 22 or group practice by health care practitioners where no
- 23 reviewable clinically related health service is offered, a
- 24 facility providing treatment solely on the basis of prayer or
- 25 spiritual means in accordance with the tenets of any church or
- 26 religious denomination or a facility conducted by a religious
- 27 organization for the purpose of providing health care services
- 28 exclusively to clergy or other persons in a religious profession
- 29 who are members of the religious denominations conducting the
- 30 facility.

- 1 "Operating room of the facility." The phrase shall only
- 2 include the number of operating rooms contained in the
- 3 ambulatory surgical facilities license issued by the
- 4 Pennsylvania Department of Health.
- 5 "Registered nurse." An individual licensed under the laws of
- 6 this Commonwealth to practice professional nursing.
- 7 Section 4. Operating room staff.
- 8 Only a registered nurse, licensed in this Commonwealth,
- 9 qualified by training and experience in operating room nursing
- 10 shall be present as a circulating nurse during all surgical
- 11 procedures in a health care facility for the duration of the
- 12 procedure with the exception of the following surgical
- 13 procedures when such procedures THAT are not performed under <---

- 14 general anesthesia or conscious sedation in an ambulatory
- 15 surgical facility:
- 16 (1) Endoscopy.
- 17 (2) Pain management.
- $\frac{(3)}{\text{Lasik eye.}}$
- 19 (4) Extracorporeal shock wave therapy (ESWL).
- 20 FACILITY.
- 21 Section 5. Effective date.
- This act shall take effect in 60 days.
