JUNE 7, 2005

A RESOLUTION

1 Designating June 15, 2005, as "White Deer Run/Cove Forge, Inc.,  
2 Day" in Pennsylvania and congratulating White Deer Run/Cove  
3 Forge, Inc., on 35 years of bringing healing to Pennsylvania  
4 families of persons with alcohol and other drug addictions.

5 WHEREAS, One in every four families includes a family member  
6 with an alcohol addiction or other drug addiction; and

7 WHEREAS, One in every ten citizens of this Commonwealth has  
8 an alcohol or drug problem or addiction; and

9 WHEREAS, Addiction treatment is highly effective for youths  
10 and adults; and

11 WHEREAS, Treatment for the primary disease of alcohol and  
12 drug addiction prevents fetal alcohol and drug syndrome and  
13 other addiction-related illnesses; and

14 WHEREAS, Treatment for the primary disease of alcohol and  
15 drug addiction reduces crime and driving under the influence  
16 while improving safety in communities, neighborhoods and  
17 schools; and

18 WHEREAS, Studies have repeatedly demonstrated that treatment

1 of alcohol and drug addiction saves at least \$7 for every \$1  
2 invested; and

3 WHEREAS, White Deer Run, Inc., was established in 1970 in  
4 Allenwood, Union County, to salvage lives destroyed by alcohol  
5 and drug addiction; and

6 WHEREAS, White Deer Run/Cove Forge, Inc., has expanded  
7 Statewide and provides treatment services in Allegheny, Berks,  
8 Blair, Cambria, Columbia, Dauphin, Erie, Franklin, Lancaster,  
9 Lawrence, Lebanon, Lehigh, Lycoming, Schuylkill, Union and  
10 Westmoreland Counties; and

11 WHEREAS, White Deer Run/Cove Forge, Inc., has provided  
12 recovery services to more than 200,000 individuals seeking help;  
13 therefore be it

14 RESOLVED, That the House of Representatives designate June  
15 15, 2005, as "White Deer Run/Cove Forge, Inc., Day" in  
16 Pennsylvania; and be it further

17 RESOLVED, That the House of Representatives congratulate  
18 White Deer Run/Cove Forge, Inc., for 35 years of bringing  
19 healing to Pennsylvania families of persons with alcohol and  
20 other drug addictions.
