A RESOLUTION

1 Expressing condolences to the family of Spc. Eric W. Slebodnik
2 of Greenfield Township, Lackawanna County, a member of the
3 Pennsylvania Army National Guard who was killed in Iraq while
4 serving his country on September 28, 2005.

5 WHEREAS, Spc. Eric W. Slebodnik was a resident of Greenfield
6 Township, Lackawanna County, and served in Pennsylvania Army
7 National Guard Company C, 1/109th Infantry (Mechanized); and

8 WHEREAS, Spc. Eric W. Slebodnik was a junior history major at
9 Indiana University of Pennsylvania; and

10 WHEREAS, Spc. Eric W. Slebodnik was deployed to Iraq in June
11 2005; and

12 WHEREAS, Spc. Eric W. Slebodnik was tragically killed by an
13 enemy assault while providing security for the construction of a
14 railroad bridge near Ramadi, Iraq; and

15 WHEREAS, Spc. Eric W. Slebodnik paid the ultimate price by

1 giving his life in the service of his country and this
2 Commonwealth; and

3 WHEREAS, Spc. Eric W. Slebodnik was 21 years of age and is
4 survived by his mother, father and younger brother; and

5 WHEREAS, The Commonwealth recognizes the supreme sacrifice
6 made by Spc. Eric W. Slebodnik and the profound grief of his
7 family; therefore be it

8 RESOLVED, That the House of Representatives express
9 condolences to the family of Spc. Eric W. Slebodnik of
10 Greenfield Township, Lackawanna County, a member of the
11 Pennsylvania Army National Guard who was killed in Iraq while
12 serving his country on September 28, 2005; and be it further

14 Spc. Slebodnik's mother and father, Mrs. Cynthia Slebodnik and
