- 1 Honoring the life and extending condolences for the supreme
- 2 sacrifice of Lance Corporal Jason L. Frye, 2nd Battalion, 2nd
- 3 Marine Regiment, 2nd Marine Division, II Marine Expeditionary
- 4 Force, based at Camp Lejeune, North Carolina, who tragically
- 5 lost his life while in the service of his country near Al
- 6 Karmah, Iraq, on October 6, 2005.
- 7 WHEREAS, Lance Corporal Jason L. Frye was born February 1,
- 8 1986, at home, in Landisburg, Perry County; and
- 9 WHEREAS, LCpl. Frye graduated in 2004 from West Perry High

- 1 School and Cumberland-Perry Vo-Tech and enlisted in the Marine
- 2 Corps that same year; and
- 3 WHEREAS, After completing basic training at Parris Island,
- 4 South Carolina in January, LCpl. Frye was assigned to the 2nd
- 5 Battalion, 2nd Marine Regiment, 2nd Marine Division, II Marine
- 6 Expeditionary Force based at Camp Lejeune, North Carolina; and
- 7 WHEREAS, His unit's deployment to Iraq this summer was for
- 8 the purpose of providing security in and around Al Karmah, Iraq;
- 9 and
- 10 WHEREAS, On October 6, LCpl. Frye, a machine gunner on a
- 11 Humvee, died instantly, along with three other marines, from
- 12 injuries incurred when an improvised explosive device blew up
- 13 the vehicle near Al Karmah, Iraq; and
- 14 WHEREAS, LCpl. Frye, beloved son of Connie and Gary Frye and
- 15 beloved brother of Adam, was courageously serving his country
- 16 and the campaign for Operation Iraqi Freedom at the time of his
- 17 death; therefore be it
- 18 RESOLVED, That the House of Representatives honor the life
- 19 and extend condolences for the supreme sacrifice of LCpl. Jason
- 20 L. Frye, who died on October 6, 2005, while in the courageous
- 21 service of his country; and be it further
- 22 RESOLVED, That a copy of this resolution be transmitted to
