AN ACT

- 1 Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An
- act to consolidate, editorially revise, and codify the public
- 3 welfare laws of the Commonwealth, " further providing for
- 4 payments to counties for services to children.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 704.1(q) of the act of June 13, 1967
- 8 (P.L.31, No.21), known as the Public Welfare Code, is amended
- 9 and the section is amended by adding a subsection to read:
- 10 Section 704.1. Payments to Counties for Services to
- 11 Children.--* * *
- 12 (b.1) Payments shall be made in equal quarterly installments
- 13 of the amount fixed by section 709.3, the first of which shall
- 14 be for the quarter beginning July 1 and ending September 30; the
- 15 second installment shall be for the quarter beginning October 1
- 16 and ending December 31; the third installment shall be for the
- 17 quarter beginning January 1 and ending March 31; and the fourth
- 18 installment shall be for the quarter beginning April 1 and

- 1 ending June 30; the local contribution required under this
- 2 <u>section shall not be required to be paid until the fourth</u>
- 3 quarter payment is due. The quarterly payment shall be paid at
- 4 the beginning of each quarter for which the county institution
- 5 <u>district or its successor has budgeted an amount equal to one</u>
- 6 quarter of the annual local contribution required. At the close
- 7 of the fourth quarter, the total payments made to the county
- 8 <u>institution district or its successor in accordance with section</u>
- 9 709.3 shall be reconciled and adjusted in accordance with this
- 10 section and section 709.3.
- 11 * * *
- 12 [(g) The department shall, within forty-five days of each
- 13 calendar quarter, pay fifty percent of the department's share of
- 14 the county institution district's or its successor's estimated
- 15 expenditures for that quarter.]
- 16 * * *
- 17 Section 2. This act shall take effect immediately.
