AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- 2 Consolidated Statutes, further providing for the offense of
- 3 luring a child into a motor vehicle.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 2910 of Title 18 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 2910. Luring a child into a motor vehicle or structure.
- 9 (a) Offense.--Unless the circumstances reasonably indicate
- 10 that the child is in need of assistance, a person who lures or
- 11 attempts to lure a child into a motor vehicle or structure
- 12 without the consent, express or implied, of the child's parent
- 13 or guardian commits a [misdemeanor of the first] felony of the

- 1 third degree.
- 2 (b) Affirmative defense. -- It shall be an affirmative defense
- 3 to a prosecution under this section that the person lured or
- 4 attempted to lure the child into the structure for a lawful
- 5 purpose.
- 6 (c) Definitions.--As used in this section, the following
- 7 words and phrases shall have the meanings given to them in this
- 8 subsection:
- 9 "Motor vehicle." Every self-propelled device in, upon or by
- 10 which any person or property is or may be transported or drawn
- 11 on a public highway.
- "Structure." A house, apartment building, shop, warehouse,
- 13 barn, building, vessel, railroad car, cargo container, house
- 14 car, trailer, trailer coach, camper, mine, floating home or
- 15 other enclosed structure capable of holding a child, which is
- 16 not open to the general public.
- 17 Section 2. This act shall take effect in 60 days.
