AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial 4 schools; amending, revising, consolidating and changing the laws relating thereto," further providing for eligibility and 6 for qualifications; AND PROVIDING FOR CONTINUING PROFESSIONAL DEVELOPMENT FOR SCHOOL AND SYSTEM LEADERS AND FOR 7 8 PENNSYLVANIA SCHOOL LEADERSHIP STANDARDS. 9 The General Assembly of the Commonwealth of Pennsylvania 10 hereby enacts as follows: 11 Section 1. Section 1003 of the act of March 10, 1949 12 (P.L.30, No.14), known as the Public School Code of 1949, 13 amended December 19, 1975 (P.L.511, No.150), is amended to read: 14 Section 1003. Eligibility. [No] (a) Except as provided in 15 subsection (b), no person shall be eligible for election or 16 appointment as a district[,] or assistant district superintendent[, unless] unless all of the following apply: 17 18 (1) [He] The person holds a diploma from a college or other institution approved by the Department of Education[;]. 19 (2) [He] The person has had six (6) years' successful 20

- 1 teaching experience, not less than three of which shall have
- 2 been in a supervisory or administrative capacity[;].
- 3 (3) [He] The person has completed in a college or university
- 4 a graduate [course] program in education approved by the
- 5 Department of Education[;]. Completion of the program shall not
- 6 be subject to waiver under section 1714 B unless the candidate
- 7 provides to the Secretary of Education evidence that the
- 8 <u>candidate has successfully completed an equivalent leadership</u>
- 9 <u>development program that addresses the standards specified in</u>
- 10 regulations of the State Board of Education.
- 11 [(4) Provided that in] (b) (1) In school districts of the
- 12 first class, five (5) years of administrative experience at the
- 13 level of assistant, associate or deputy superintendent[,] may be
- 14 substituted for prescribed graduate administrative courses[, and
- 15 which]. It shall be the responsibility of the Secretary of
- 16 Education to review these equivalences to conform with State
- 17 board regulations.
- 18 <u>(2)</u> Serving either as county, district[,] or assistant
- 19 county [or], district [superintendent,] or associate
- 20 superintendent, in this Commonwealth[, at the time this act
- 21 becomes effective, on July 1, 1949 or, in a school district of
- 22 <u>the first class, on January 1, 1950</u> shall, [irrespective of the
- 23 foregoing requirements,] be considered sufficient qualification
- 24 for [any of the aforesaid offices] assistant county, district or
- 25 associate superintendent.
- 26 SECTION 1003. ELIGIBILITY.--NO PERSON SHALL BE ELIGIBLE FOR
- 27 ELECTION OR APPOINTMENT AS A DISTRICT, OR ASSISTANT DISTRICT
- 28 SUPERINTENDENT, UNLESS--
- 29 (1) HE HOLDS A DIPLOMA FROM A COLLEGE OR OTHER INSTITUTION
- 30 APPROVED BY THE DEPARTMENT OF EDUCATION;

- 1 (2) HE HAS HAD SIX (6) YEARS' SUCCESSFUL TEACHING
- 2 EXPERIENCE, NOT LESS THAN THREE OF WHICH SHALL HAVE BEEN IN A
- 3 SUPERVISORY OR ADMINISTRATIVE CAPACITY;
- 4 (3) HE HAS COMPLETED IN A COLLEGE OR UNIVERSITY A GRADUATE
- 5 [COURSE] PROGRAM IN EDUCATION APPROVED BY THE DEPARTMENT OF
- 6 EDUCATION[;] THAT INCLUDES THE PENNSYLVANIA SCHOOL LEADERSHIP
- 7 STANDARDS UNDER SECTION 1217. COMPLETION OF THE PROGRAM SHALL
- 8 NOT BE SUBJECT TO WAIVER UNDER SECTION 1714-B UNLESS THE
- 9 CANDIDATE PROVIDES TO THE SECRETARY OF EDUCATION EVIDENCE THAT
- 10 HE HAS SUCCESSFULLY COMPLETED AN EQUIVALENT LEADERSHIP
- 11 <u>DEVELOPMENT PROGRAM THAT ADDRESSES THE SCHOOL LEADERSHIP</u>
- 12 STANDARDS UNDER SECTION 1217.
- 13 (4) PROVIDED THAT IN SCHOOL DISTRICTS OF THE FIRST CLASS,
- 14 FIVE (5) YEARS OF ADMINISTRATIVE EXPERIENCE AT THE LEVEL OF
- 15 ASSISTANT, ASSOCIATE OR DEPUTY SUPERINTENDENT, MAY BE
- 16 SUBSTITUTED FOR PRESCRIBED GRADUATE ADMINISTRATIVE COURSES, AND
- 17 WHICH SHALL BE THE RESPONSIBILITY OF THE SECRETARY OF EDUCATION
- 18 TO REVIEW THESE EQUIVALENCES TO CONFORM WITH STATE BOARD
- 19 REGULATIONS.
- 20 SERVING EITHER AS COUNTY, DISTRICT, OR ASSISTANT COUNTY OR
- 21 DISTRICT SUPERINTENDENT, OR ASSOCIATE SUPERINTENDENT, IN THIS
- 22 COMMONWEALTH, AT THE TIME THIS ACT BECOMES EFFECTIVE, SHALL,
- 23 IRRESPECTIVE OF THE FOREGOING REQUIREMENTS, BE CONSIDERED
- 24 SUFFICIENT QUALIFICATION FOR ANY OF THE AFORESAID OFFICES.
- Section 2. Section 1109 of the act, amended March 19, 1970
- 26 (P.L.189, No.73), is amended to read:
- 27 Section 1109. Qualifications.--(a) Every teacher employed
- 28 to teach in the public schools of this Commonwealth must be a
- 29 person of good moral character, must be at least eighteen years
- 30 of age, and must be a citizen of the United States: Provided,

- 1 That citizenship may be waived in the case of exchange teachers
- 2 not permanently employed, and teachers employed for the purpose
- 3 of teaching foreign languages, including special teachers who
- 4 speak the idiomatic or colloquial language of immigrants
- 5 residing in the school district, and employed for the purpose of
- 6 easing the transition period of such immigrants.
- 7 (b) Every principal appointed after August thirty-first, one
- 8 thousand nine hundred fifty-three, employed in the public
- 9 schools of this Commonwealth, who devotes one-half or more of
- 10 his time to supervision and administration, shall be properly
- 11 certificated by the Department of Public Instruction in
- 12 accordance with such standards as the State Board of Education
- 13 may establish.
- 14 <u>(c) Individuals who apply after January 1, 2008, for a </u>
- 15 <u>certificate to become eligible to serve as a principal or</u>
- 16 assistant principal in a public school in this Commonwealth and
- 17 who otherwise meet the requirements for the certificate shall be
- 18 issued an Administrative I certificate. No individual may serve
- 19 as a principal or assistant principal on an Administrative I
- 20 certificate for more than five school years.
- 21 <u>(d) The holder of an Administrative I certificate shall be</u>
- 22 issued an Administrative II certificate upon application to the
- 23 department verifying three years of satisfactory service on an
- 24 Administrative I certificate and successful completion of a
- 25 <u>professional development program for administrators as described</u>
- 26 <u>in regulations of the State Board of Education.</u>
- 27 (C) INDIVIDUALS WHO WERE GRANTED AN ADMINISTRATIVE
- 28 CERTIFICATE BY THE DEPARTMENT OF EDUCATION PRIOR TO JANUARY 1,
- 29 2008, AND WHO ARE EMPLOYED FOR THE FIRST TIME IN A POSITION OF
- 30 PRINCIPAL, VICE PRINCIPAL OR ASSISTANT PRINCIPAL IN A PUBLIC

- 1 SCHOOL OF THIS COMMONWEALTH ON OR AFTER JANUARY 1, 2008, SHALL
- 2 COMPLETE THE INDUCTION PROGRAM PROVIDED FOR IN SUBSECTION (F)
- 3 WITHIN FIVE YEARS OF APPOINTMENT AS A PRINCIPAL, VICE PRINCIPAL
- 4 OR ASSISTANT PRINCIPAL.
- 5 (D) INDIVIDUALS WHO APPLY ON OR AFTER JANUARY 1, 2008, FOR A
- 6 CERTIFICATE TO BECOME ELIGIBLE TO SERVE AS A PRINCIPAL, VICE
- 7 PRINCIPAL OR ASSISTANT PRINCIPAL IN A PUBLIC SCHOOL IN THIS
- 8 COMMONWEALTH AND WHO OTHERWISE MEET THE REQUIREMENTS FOR SUCH
- 9 <u>CERTIFICATE SHALL BE ISSUED AN ADMINISTRATIVE I CERTIFICATE. NO</u>
- 10 INDIVIDUAL MAY SERVE AS A PRINCIPAL, VICE PRINCIPAL OR ASSISTANT
- 11 PRINCIPAL ON AN ADMINISTRATIVE I CERTIFICATE FOR MORE THAN FIVE
- 12 <u>SCHOOL YEARS.</u>
- 13 (E) THE HOLDER OF AN ADMINISTRATIVE I CERTIFICATE SHALL BE
- 14 ISSUED AN ADMINISTRATIVE II CERTIFICATE UPON APPLICATION TO THE
- 15 <u>DEPARTMENT OF EDUCATION VERIFYING THREE YEARS OF SATISFACTORY</u>
- 16 SERVICE ON AN ADMINISTRATIVE I CERTIFICATE AND SUCCESSFUL
- 17 COMPLETION OF THE INDUCTION PROGRAM DESCRIBED IN SUBSECTION (F).
- 18 (F) THE DEPARTMENT OF EDUCATION SHALL DESIGN AND OFFER AN
- 19 INDUCTION PROGRAM AT NO COST TO THOSE PRINCIPALS, VICE
- 20 PRINCIPALS AND ASSISTANT PRINCIPALS WHO PARTICIPATE AND AT NO
- 21 COST TO THEIR EMPLOYER SCHOOL ENTITIES AND SHALL APPROVE OTHER
- 22 PROVIDERS TO OFFER INDUCTION PROGRAMS. ALL INDUCTION PROGRAMS
- 23 SHALL BE DESIGNED TO AID IN DEVELOPMENT IN THE CORE SCHOOL
- 24 <u>LEADERSHIP STANDARDS IDENTIFIED IN SECTION 1217(A)(1).</u>
- 25 PARTICIPANTS IN AN INDUCTION PROGRAM SHALL NOT BE REQUIRED TO
- 26 ATTEND MORE THAN THIRTY-SIX (36) HOURS OF INDUCTION DURING ANY
- 27 ONE SCHOOL YEAR OR A TOTAL OF ONE HUNDRED EIGHT (108) HOURS.
- 28 HOURS OF PARTICIPATION IN AN INDUCTION PROGRAM SHALL BE APPLIED
- 29 TOWARD MEETING THE CERTIFICATE HOLDER'S CONTINUING PROFESSIONAL
- 30 EDUCATION REQUIREMENTS UNDER SECTION 1205.2.

- 1 SECTION 3. THE ACT IS AMENDED BY ADDING SECTIONS TO READ:
- 2 <u>SECTION 1205.5. CONTINUING PROFESSIONAL DEVELOPMENT FOR</u>
- 3 SCHOOL AND SYSTEM LEADERS. -- (A) BEGINNING JANUARY 1, 2008,
- 4 EVERY SCHOOL AND SYSTEM LEADER SHALL MEET THE CONTINUING
- 5 PROFESSIONAL EDUCATION REQUIREMENTS OF SECTION 1205.2 THROUGH
- 6 PARTICIPATION IN PROGRAMS APPROVED IN ACCORDANCE WITH THIS
- 7 SECTION. FOR ANY CERTIFICATE HOLDER WHO SERVES IN BOTH
- 8 ADMINISTRATIVE AND NONADMINISTRATIVE POSITIONS DURING A
- 9 COMPLIANCE PERIOD AS DEFINED IN SECTION 1205.2, THE CERTIFICATE
- 10 HOLDER'S CONTINUING EDUCATION CREDIT REQUIREMENTS SHALL BE
- 11 EARNED IN PROGRAMS APPROVED IN ACCORDANCE WITH THIS SECTION IN
- 12 NO LESS THAN THE SAME PROPORTION AS THE PROPORTION OF THE
- 13 COMPLIANCE PERIOD DURING WHICH THE CERTIFICATE HOLDER SERVED ON
- 14 AN ADMINISTRATIVE CERTIFICATE OR LETTER OF ELIGIBILITY.
- 15 (B) FOR THE COMPLIANCE PERIOD IN EFFECT ON JANUARY 1, 2008,
- 16 THIS SECTION SHALL ONLY APPLY TO ANY CREDITS OR HOURS NEEDED TO
- 17 SATISFY THE UNMET REQUIREMENTS OF THE CURRENT COMPLIANCE PERIOD.
- 18 (C) THE DEPARTMENT OF EDUCATION SHALL DESIGN AND OFFER
- 19 CONTINUING PROFESSIONAL DEVELOPMENT PROGRAMS AT NO COST TO
- 20 SCHOOL AND SYSTEM LEADERS WHO ARE REQUIRED BY THIS SECTION TO
- 21 PARTICIPATE AND AT NO COST TO THEIR EMPLOYER SCHOOL ENTITIES. IN
- 22 THE EVENT THAT INDIVIDUALS ARE UNABLE TO ACCESS THESE PROGRAMS
- 23 BECAUSE ALL AVAILABLE SLOTS ARE FILLED, THE INDIVIDUAL MAY
- 24 REQUEST AND SHALL BE GRANTED UPON REVIEW BY THE DEPARTMENT AN
- 25 EXTENSION OF THE COMPLIANCE PERIOD.
- 26 (D) THE DEPARTMENT OF EDUCATION SHALL APPROVE OTHER
- 27 PROVIDERS TO OFFER INDUCTION AND CONTINUING PROFESSIONAL
- 28 DEVELOPMENT PROGRAMS FOR SCHOOL AND SYSTEM LEADERS AND SHALL
- 29 <u>ANNUALLY PUBLISH A LIST OF APPROVED PROVIDERS.</u>
- 30 (E) ALL PROGRAMS OFFERED OR APPROVED BY THE DEPARTMENT OF

- 1 EDUCATION UNDER THIS SECTION SHALL ADDRESS THE PENNSYLVANIA
- 2 <u>SCHOOL LEADERSHIP STANDARDS PURSUANT TO SECTION 1217.</u>
- 3 (F) THE SECRETARY OF EDUCATION MAY ADOPT STANDARDS AS
- 4 NECESSARY TO IMPLEMENT THIS SECTION.
- 5 (G) FOR THE PURPOSE OF THIS SECTION, SCHOOL AND SYSTEM
- 6 LEADERS SHALL INCLUDE ANY INDIVIDUAL SERVING ON A CERTIFICATE AS
- 7 A PRINCIPAL, VICE PRINCIPAL, ASSISTANT PRINCIPAL,
- 8 SUPERINTENDENT, ASSISTANT SUPERINTENDENT, INTERMEDIATE UNIT
- 9 EXECUTIVE DIRECTOR, ASSISTANT INTERMEDIATE UNIT EXECUTIVE
- 10 DIRECTOR OR DIRECTOR OF AN AREA VOCATIONAL-TECHNICAL SCHOOL.
- 11 <u>SECTION 1217. PENNSYLVANIA SCHOOL LEADERSHIP STANDARDS.--(A)</u>
- 12 PROGRAMS PROVIDED UNDER SECTION 1205.5(C) AND (D) TO PREPARE
- 13 SCHOOL AND SYSTEM LEADERS AND FOR PURPOSES OF ISSUING
- 14 ADMINISTRATOR CERTIFICATES OR LETTERS OF ELIGIBILITY AND
- 15 APPROVED PROGRAMS FOR THE INDUCTION AND CONTINUING PROFESSIONAL
- 16 <u>DEVELOPMENT OF SCHOOL AND SYSTEM LEADERS SHALL ADDRESS:</u>
- 17 (1) THE FOLLOWING CORE STANDARDS:
- 18 (I) THE KNOWLEDGE AND SKILLS TO THINK AND PLAN STRATEGICALLY
- 19 CREATING AN ORGANIZATIONAL VISION AROUND PERSONALIZED STUDENT
- 20 SUCCESS.
- 21 (II) AN UNDERSTANDING OF STANDARDS-BASED SYSTEMS THEORY AND
- 22 DESIGN AND THE ABILITY TO TRANSFER THAT KNOWLEDGE TO THE
- 23 LEADER'S JOB AS THE ARCHITECT OF STANDARDS-BASED REFORM IN THE
- 24 SCHOOL.
- 25 (III) THE ABILITY TO ACCESS AND USE APPROPRIATE DATA TO
- 26 <u>INFORM DECISION-MAKING AT ALL LEVELS OF THE SYSTEM.</u>
- 27 (2) THE FOLLOWING COROLLARY STANDARDS:
- 28 (I) CREATING A CULTURE OF TEACHING AND LEARNING WITH AN
- 29 <u>EMPHASIS ON LEARNING.</u>
- 30 (II) MANAGING RESOURCES FOR EFFECTIVE RESULTS.

- 1 (III) COLLABORATING, COMMUNICATING, ENGAGING AND EMPOWERING
- 2 OTHERS INSIDE AND OUTSIDE OF THE ORGANIZATION TO PURSUE
- 3 EXCELLENCE IN LEARNING.
- 4 (IV) OPERATING IN A FAIR AND EQUITABLE MANNER WITH PERSONAL
- 5 AND PROFESSIONAL INTEGRITY.
- 6 (V) ADVOCATING FOR CHILDREN AND PUBLIC EDUCATION IN THE
- 7 LARGER POLITICAL, SOCIAL, ECONOMIC, LEGAL AND CULTURAL CONTEXT.
- 8 (VI) SUPPORTING PROFESSIONAL GROWTH OF SELF AND OTHERS
- 9 THROUGH PRACTICE AND INQUIRY.
- 10 (B) THE STATE BOARD OF EDUCATION MAY PROMULGATE REGULATIONS
- 11 TO CARRY OUT THE PROVISIONS OF THIS SECTION.
- 12 (C) FOR THE PURPOSE OF THIS SECTION, SCHOOL AND SYSTEM
- 13 <u>LEADERS SHALL INCLUDE ANY INDIVIDUAL SERVING ON A CERTIFICATE AS</u>
- 14 <u>A PRINCIPAL, VICE PRINCIPAL, ASSISTANT PRINCIPAL,</u>
- 15 <u>SUPERINTENDENT</u>, <u>ASSISTANT SUPERINTENDENT</u>, <u>INTERMEDIATE UNIT</u>
- 16 EXECUTIVE DIRECTOR, ASSISTANT INTERMEDIATE UNIT EXECUTIVE
- 17 DIRECTOR OR DIRECTOR OF AN AREA VOCATIONAL-TECHNICAL SCHOOL.
- 18 Section 2 4. This act shall take effect July 1, 2007, or
- 19 immediately, whichever is later.
