## AN ACT

1 Amending the act of April 9, 1929 (P.L.177, No.175), entitled  
2 "An act providing for and reorganizing the conduct of the  
3 executive and administrative work of the Commonwealth by the  
4 Executive Department thereof and the administrative  
5 departments, boards, commissions, and officers thereof,  
6 including the boards of trustees of State Normal Schools, or  
7 Teachers Colleges; abolishing, creating, reorganizing or  
8 authorizing the reorganization of certain administrative  
9 departments, boards, and commissions; defining the powers and  
10 duties of the Governor and other executive and administrative  
11 officers, and of the several administrative departments,  
12 boards, commissions, and officers; fixing the salaries of the  
13 Governor, Lieutenant Governor, and certain other executive  
14 and administrative officers; providing for the appointment of  
15 certain administrative officers, and of all deputies and  
16 other assistants and employes in certain departments, boards,  
17 and commissions; and prescribing the manner in which the  
18 number and compensation of the deputies and all other  
19 assistants and employes of certain departments, boards and  
20 commissions shall be determined," further providing for the  
21 establishment of certain fees in the Department of  
22 Environmental Protection; and making repeals.

23 The General Assembly of the Commonwealth of Pennsylvania

24 hereby enacts as follows:

13       (b) Notwithstanding the establishment of the fees in  
 14       paragraphs (a)(8) through (14), the Department of Environmental  
 15       Protection, including the Environmental Quality Board, shall  
 16       continue to exercise the authority previously granted to  
 17       establish or change fees by regulation.

18       (c) The Department of Environmental Protection will review  
 19       the adequacy of the fees established in subsection (a) at least  
 20       once every three years and provide a written report to the  
 21       Environmental Quality Board. The report shall identify any  
 22       disparity between the amount of program income generated by the  
 23       fees and the costs to administer these programs and shall  
 24       contain recommendations to increase fees to eliminate the  
 25       disparity, including recommendations for regulatory amendments  
 26       to increase program fees.

27       (d) The additional municipal waste disposal fee established  
 28       in paragraph (a)(13)(i) shall be allocated as follows:  
 29            (1) \$2.25 shall be deposited into the Hazardous Sites  
 30            Cleanup Fund established under section 901 of the act of

1       October 18, 1988 (P.L.756, No.108), known as the "Hazardous  
2       Sites Cleanup Act," and the department may expend these  
3       moneys in accordance with section 902 of the "Hazardous Sites  
4       Cleanup Act.."

5           (2) .50 shall be deposited into the Environmental  
6       Stewardship Fund established in 27 Pa.C.S. § 6104 (relating  
7       to fund) and the department may expend these moneys in  
8       accordance with 27 Pa.C.S. Ch. 61 (relating to environmental  
9       stewardship and watershed protection), including payments  
10      authorized by 27 Pa.C.S. § 6115(d)(4) (relating to debt  
11      retirement).

12       (e) The well permit fee established in subsection  
13      (a)(15)(xi) shall be allocated as follows:

14          (1) \$1,375.00 shall be placed in the General Fund.  
15          (2) \$100.00 shall be appropriated to the Department of  
16       Environmental Protection to carry out the purposes of the act  
17       of December 19, 1984 (P.L.1140, No.223), known as the "Oil  
18       and Gas Act."

19       Section 2. Repeals are as follows:

20          (1) The General Assembly declares that the repeal under  
21       paragraph (2) is necessary to effectuate the addition of  
22       section 607-A(a)(10)(xxix).

23          (2) Section 903(d)(1) of the act of October 18, 1988  
24       (P.L.756, No.108), known as the Hazardous Sites Cleanup Act,  
25       is repealed insofar as it relates to the fee to be charged.

26          (3) All other acts and parts of acts are repealed  
27       insofar as they are inconsistent with this act.

28       Section 3. This act shall take effect July 1, 2007, or  
29       immediately, whichever is later.
