AN ACT

1 Amending Title 42 (Judiciary and Judicial Procedure) of the  
2 Pennsylvania Consolidated Statutes, further providing for the  
3 number of judges in the courts of common pleas.

4 The General Assembly of the Commonwealth of Pennsylvania  
5 hereby enacts as follows:

6 Section 1. Section 911(a) of Title 42 of the Pennsylvania  
7 Consolidated Statutes, amended November 30, 2004 (P.L.1703,  
8 No.217), is amended to read:

9 § 911. Courts of common pleas.

10 (a) General rule.--There shall be one court of common pleas  
11 for each judicial district of this Commonwealth consisting of  
12 the following number of judges:

30 not be applicable to the selection of judges for the judgeships

2 (b) (1) Except as otherwise provided under paragraph (2),  
3 the new judgeships added by the amendment of 42 Pa.C.S. §  
4 911(a) shall be established on January 4, 2010, and shall be  
5 initially filled by election at the 2009 municipal election.

6 (2) The new ~~judgeship for the~~ JUDGESHIPS FOR THE NINTH <—  
7 AND thirty-ninth judicial ~~district~~ DISTRICTS of this <—  
8 Commonwealth added by the amendment of 42 Pa.C.S. § 911(a)  
9 shall be established on January 2, 2012, and shall be  
10 initially filled by election at the 2011 municipal election.  
11 Section 3. This act shall take effect in 60 days.
