AN ACT

1 2	Authorizing the Department of Transportation to sell land under certain conditions; and making a related repeal.
3	The General Assembly of the Commonwealth of Pennsylvania
4	hereby enacts as follows:
5	Section 1. Short title.
6	This act shall be known and may be cited as the Sale of
7	Transportation Lands Act.
8	Section 2. Definitions.
9	The following words and phrases when used in this act shall
10	have the meanings given to them in this section unless the
11	context clearly indicates otherwise:

(2) Protection and conservation of forests and land

13 (8) Promotion of sound, cohesive and efficient land 14 development by preserving open spaces between communities. 15 "Public agency." Includes an authority and a political 16 subdivision.

19 Section 3. Sale of land.

20 (a) Authorization.--Notwithstanding the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, the 21 department, in accordance with appropriations and grants of 22 23 funds from Federal, State, regional, local or private agencies 24 and subject to subsection (b), in the exercise of its powers and 25 duties, may sell at public sale land acquired by the department 26 if the secretary determines that the land is not needed for present or future transportation purposes. 27

(b) Conditions.--The following apply to a sale undersubsection (a):

30 (1) If the land is improved, all of the following

1 subparagraphs apply:

2 (i) The land must first be offered at its fair 3 market value as determined by the department to other public agencies which demonstrate a public purpose for 4 the land, including, BUT NOT LIMITED TO, the preservation 5 ← 6 of open space. 7 (ii) If the land is not transferred to a public 8 agency, all of the following clauses apply: 9 If the land is occupied by a tenant, the (A) 10 land must be offered to the tenant: 11 (I) except as set forth in subclause (II), 12 at its fair market value as determined by the 13 department; or if the tenant is the person from whom 14 (II)15 the department acquired the land, at the 16 acquisition price, less costs, expenses and 17 reasonable attorney fees incurred by the person 18 as a result of the acquisition of the land by the 19 department. 20 If the land is not occupied by a tenant and (B) 21 the person from whom the department acquired the land 22 did not receive a replacement housing payment under 23 26 Pa.C.S. § 903 (relating to replacement housing for 24 homeowners) or under former section 304.3 of the act 25 of June 1, 1945 (P.L.1242, No.428), known as the 26 State Highway Law, the land must first be offered to 27 that person at the acquisition price, less costs, 28 expenses and reasonable attorney fees incurred by the 29 person as a result of the acquisition of the land by 30 the department.

(2) If the land is unimproved, all of the following
 subparagraphs apply:

3 (i) The land must be offered at its fair market
4 value as determined by the department to other public
5 agencies which demonstrate a public purpose for the land,
6 including, BUT NOT LIMITED TO, the preservation of open
7 space.

8 (ii) If the land is not transferred to a public9 agency, the following apply:

10 (A) Except as set forth in clause (B), the land 11 must be offered to the person from whom it was 12 acquired at its acquisition price, less costs, 13 expenses and reasonable attorney fees incurred by the 14 person as a result of the acquisition of the land by 15 the department, IF THE PERSON STILL RETAINS TITLE TO 16 LAND ABUTTING THE LAND TO BE SOLD.

17 (B) If the land abutting the land to be sold has
18 been conveyed to another person, the land to be sold
19 must be offered to that person at its fair market
20 value as determined by the department.

21 (3) For an offer under paragraph (1) or (2), all of the 22 following apply:

23 (i) except as set forth in subparagraph (ii), notice
24 must be sent by certified mail;

(ii) if notice cannot be effected under subparagraph
(i), notice must be effected in the manner required for
an in rem proceeding; or

(iii) the offeree must have 120 days after receipt
of notice to accept the offer in writing.

30 (c) Proceeds.--Proceeds from a sale of land acquired with

1 money from the fund shall be deposited into the fund.

2 Section 9. Repeals.

3 Repeals are as follows:

4 (1) The General Assembly declares that the repeal under 5 paragraph (2) is necessary to effectuate section 3.

9 Section 10. Effective date.
