- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 CHAPTER 1
- 10 PRELIMINARY PROVISIONS
- 11 Section 101. Short title.
- 12 This act shall be known and may be cited as the Municipal
- 13 Volunteer Firefighter Incentive Act.
- 14 Section 102. Purpose.
- The purpose of this act is to authorize municipalities to
- 16 enact a tax credit against an active volunteer firefighter's
- 17 earned income tax liability as a financial incentive to:
- 18 (1) Indicate the municipality's acknowledgment of the
- value of and the absence of any public cost for volunteer
- fire protection provided by active volunteer firefighters.
- 21 (2) To encourage other individuals to newly volunteer or
- for former firefighters to consider rejoining as an active
- volunteer firefighter in a volunteer fire company.
- 24 Section 103. Definitions.
- 25 The following words and phrases when used in this act shall
- 26 have the meanings given to them in this section unless the
- 27 context clearly indicates otherwise:
- 28 "Active volunteer firefighter." A volunteer firefighter who
- 29 has complied with the requirements of the volunteer fire service
- 30 credit program and who is certified by the State Fire-

- 1 Commissioner under section 504 503.
- 2 "Commissioner." The State Fire Commissioner of the
- 3 Commonwealth.
- 4 "Department." The Department of Revenue of the Commonwealth.
- 5 "Earned income tax." A tax on earned income and net profits
- 6 levied under chapter 3 of the act of December 31, 1965 (P.L.
- 7 1257, No.511), known as The Local Tax Enabling Act.
- 8 "Governing body." A city council, borough council,
- 9 incorporated town council, board of township commissioners,
- 10 board of township supervisors, governing council of a home rule
- 11 municipality or optional plan municipality or a governing
- 12 council of any similar purpose government which may be created
- 13 by statute after the effective date of this section.
- "Local Tax Enabling Act." The act of December 31, 1965 (P.L.
- 15 1257, No.511), known as The Local Tax Enabling Act.
- 16 "Municipality." A city, borough, incorporated town or
- 17 township located in this Commonwealth.
- 18 "Tax credit." The tax credit granted under section 301.
- 19 "Volunteer fire company." A nonprofit chartered corporation,
- 20 association or organization located in this Commonwealth that
- 21 provides fire protection services and may offer other voluntary
- 22 emergency services within this Commonwealth.
- "Volunteer fire service credit program." The program
- 24 established under section 501 to determine the active status of
- 25 a volunteer firefighter.
- 26 "Volunteer firefighter." A member of a volunteer fire
- 27 company.
- 28 CHAPTER 3
- 29 MUNICIPAL TAX CREDIT
- 30 Section 301. Program authorization.

- 1 (a) Establishment. -- A municipality that levies an earned
- 2 income tax may establish by resolution or ordinance a tax credit
- 3 against an individual's liability imposed under chapter 3 of the
- 4 Local Tax Enabling Act for active service as a volunteer
- 5 firefighter.
- 6 (b) Amount.--A municipality must set forth in the resolution
- 7 or ordinance the amount of the tax credit. If the total earned
- 8 income tax liability is less than the amount established by the
- 9 municipality, the tax credit shall equal the remaining tax
- 10 liability.
- 11 (c) Public notice. -- At least 30 days prior to adoption of
- 12 the resolution or ordinance, the governing body of a
- 13 municipality shall give public notice of its intent to adopt a
- 14 resolution or ordinance to establish a tax credit and conduct at
- 15 least one public hearing on the issue.
- 16 (d) Specific notice. -- A municipality that establishes a tax
- 17 credit under subsection (a) shall notify the commissioner in the
- 18 manner and pursuant to any schedule prescribed by the
- 19 commissioner.
- 20 Section 302. Claim.
- 21 (A) ELIGIBILITY. -- An individual who satisfies all of the
- 22 following criteria may claim a tax credit established under this
- 23 act:
- 24 (1) The individual is subject to an earned income tax
- imposed by a municipality that has established a tax credit
- under section 301.
- 27 (2) The individual is certified by the commissioner
- under section 504 503.
- 29 (B) RETURN.--A HUSBAND AND WIFE MAY CLAIM ANY TAX CREDIT FOR
- 30 WHICH THEY ARE ELIGIBLE ON THE SAME RETURN.

- 1 Section 303. Limitations.
- 2 A tax credit established under this act may be used against
- 3 only the individual's earned income tax liability for the
- 4 current taxable year.
- 5 CHAPTER 5
- 6 VOLUNTEER FIRE SERVICE CREDIT
- 7 Section 501. Volunteer fire service credit program.
- 8 (a) Establishment. -- Within 90 days of the effective date of
- 9 this section, the commissioner shall establish a volunteer fire
- 10 service credit program that establishes the annual requirements
- 11 for the designation of a volunteer firefighter as in active
- 12 service at a volunteer fire company.
- 13 (b) Activities. -- The volunteer fire service credit system
- 14 shall consider the following activities in determining credit
- 15 toward a designation of active service:
- 16 (1) The number of emergency calls to which a volunteer
- 17 firefighter responds.
- 18 (2) The level of training and participation in formal
- 19 training and drills for a volunteer firefighter.
- 20 (3) The total amount of time expended by a volunteer
- 21 firefighter on administrative and other support services,
- including fundraising and facility or equipment maintenance.
- 23 (4) The involvement in other events or projects that aid
- the financial viability, emergency response or operational
- 25 readiness of a volunteer fire company.
- 26 (c) Regulations.—The commissioner shall promulgate—
- 27 regulations necessary to implement this section. The-
- 28 Pennsylvania Fire Information Reporting System or any other-
- 29 system as determined by the commissioner shall be used to submit-
- 30 information required in the service record report.

- 1 (C) GUIDELINES. -- THE COMMISSIONER SHALL ADOPT GUIDELINES,
- 2 INCLUDING FORMS, NECESSARY TO IMPLEMENT THIS SECTION.
- 3 Section 502. Service record.
- 4 (a) Log. -- The chief of a volunteer fire company or the
- 5 chief's designee shall establish and maintain a service log that
- 6 documents the activities of each volunteer firefighter that
- 7 qualify for credit toward active service under the volunteer
- 8 fire service credit system and the calculation of the total
- 9 credits earned for each volunteer firefighter in the volunteer
- 10 fire company.
- 11 (b) Review.--Service logs established and maintained by
- 12 volunteer fire companies shall be subject to periodic review by
- 13 the Auditor General, the department, the governing body of the
- 14 municipality where the volunteer fire company is located and the
- 15 governing body of a municipality where the volunteer fire
- 16 company provides fire protection services or volunteer emergency
- 17 services.
- 18 Section 503. Service record report.
- 19 (a) Report. The chief of a volunteer fire company or the
- 20 chief's designee shall, within 15 days of the end of the
- 21 calendar year, submit a report to the commissioner that complies
- 22 with the requirements under subsection (b).
- 23 (b) Contents.—The report shall include all of the-
- 24 following:
- 25 (1) The name and address of each volunteer firefighter-
- 26 <u>in the volunteer fire company.</u>
- 27 (2) A calculation of the total number of credits earned
- 28 by each volunteer firefighter and a determination whether-
- 29 each volunteer firefighter qualifies for a designation as an-
- 30 active volunteer firefighter.

- 1 (3) Any additional information deemed necessary by the
- 2 commissioner.
- 3 Section 504. Certification.
- 4 (a) Compliance. On or before February 1 of each year, the
- 5 commissioner shall certify each volunteer firefighter reported
- 6 under section 503 as having complied with the requirements for
- 7 certification as an active volunteer firefighter under the
- 8 volunteer fire credit service system.
- 9 (b) Documentation. -- The commissioner, in cooperation with
- 10 the department, shall develop a procedure and a system to-
- 11 document the certification of active volunteer firefighters for
- 12 tax purposes under this act and to provide notification of the-
- 13 certification to all of the following:
- 14 (1) Each municipality that notifies the commissioner of
- 15 the establishment of a tax credit under this act.
- 16 (2) Each volunteer firefighter listed on a service
- 17 record report.
- 18 SECTION 503. CERTIFICATION.
- 19 (A) SELF-CERTIFICATION. -- THE ACTIVE VOLUNTEER FIREFIGHTER
- 20 SHALL SIGN AND SUBMIT THE APPLICATION TO THE CHIEF OF THE
- 21 VOLUNTEER FIRE COMPANY WHERE THE FIREFIGHTER SERVES.
- 22 (B) LOCAL SIGN-OFF. -- THE CHIEF AND ANOTHER OFFICER OF THE
- 23 VOLUNTEER FIRE COMPANY SHALL SIGN THE APPLICATION ATTESTING TO
- 24 THE INDIVIDUAL'S STATUS AS AN ACTIVE VOLUNTEER FIREFIGHTER. THE
- 25 APPLICATION SHALL THEN BE FORWARDED TO THE MUNICIPALITY FOR
- 26 FINAL REVIEW AND PROCESSING.
- 27 CHAPTER 30
- 28 MISCELLANEOUS PROVISIONS
- 29 Section 3001. Penalties for false reporting.
- 30 The following shall apply:

- 1 (1) Any person who knowingly makes or conspires to make
- 2 a false service record report under this act to the
- 3 commissioner commits a misdemeanor of the first degree.
- 4 (2) Any person who knowingly provides or conspires to
- 5 provide false information that is used to compile a service
- 6 record report under this act commits a misdemeanor of the
- 7 first degree.
- 8 Section 3002. Effective date.
- 9 This act shall take effect in 60 days.
