## AN ACT

Amending the act of May 17, 1921 (P.L.682, No.284), entitled "An 1 act relating to insurance; amending, revising, and 2 consolidating the law providing for the incorporation of insurance companies, and the regulation, supervision, and protection of home and foreign insurance companies, Lloyds 5 associations, reciprocal and inter-insurance exchanges, and 6 fire insurance rating bureaus, and the regulation and 7 supervision of insurance carried by such companies, 9 associations, and exchanges, including insurance carried by the State Workmen's Insurance Fund; providing penalties; and repealing existing laws," requiring health insurance policies 10 11 to provide coverage for vaccinations for human papilloma 12 13 virus. 14 The General Assembly of the Commonwealth of Pennsylvania 15 hereby enacts as follows: Section 1. The act of May 17, 1921 (P.L.682, No.284), known 16 17 as The Insurance Company Law of 1921, is amended by adding a 18 section to read: 19 Section 635.4. Coverage for Human Papilloma Virus 20 <u>Vaccinations.--(a)</u> As used in this section "health insurance 21 policies" means all group or individual health or sickness or

- 7 (3) 40 Pa.C.S. Ch. 61 (relating to hospital plan

- 9 <u>(4) 40 Pa.C.S. Ch. 63 (relating to professional health</u>
- 10 services plan corporations).
- 11 (b) All health insurance policies offered, issued or renewed
- 12 after the effective date of this section shall provide coverage
- 13 for individuals at least eleven (11) years of age and less than
- 14 <u>twenty-seven (27) years of age to receive the vaccination</u>
- 15 against human papilloma virus.
- 16 (c) This section does not include the following:
- 17 (1) accident only;
- 18 (2) limited benefit;
- 19 (3) credit;
- 20 <u>(4)</u> dental;
- 21 (5) vision;
- 22 (6) specified disease;
- 23 (7) Medicare supplement;
- 24 (8) Civilian Health and Medical Program of the Uniformed
- 25 Services (CHAMPUS) supplement;
- 26 (9) long-term care or disability income;
- 27 <u>(10) workers' compensation;</u>
- 28 (11) automobile medical payment; or
- 29 (12) any combination of hospital indemnity, accident only,
- 30 fixed indemnity, credit, dental, vision, specified disease,

- 1 Medicare supplement, Civilian Health and Medical Program of the
- 2 <u>Uniformed Services (CHAMPUS) supplement, long-term care or</u>
- 3 <u>disability income</u>, <u>workers' compensation or automobile medical</u>

- 5 Section 2. This act shall take effect in 60 days.
