## AN ACT

- Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An act to consolidate, editorially revise, and codify the public
- welfare laws of the Commonwealth," in the State blind
- 4 pension, further providing for eligibility and for amount.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 506 of the act of June 13, 1967 (P.L.31,
- 8 No.21), known as the Public Welfare Code, amended December 26,
- 9 1974 (P.L.991, No.324), June 21, 1977 (P.L.18, No.14) and April
- 10 6, 1980 (P.L.99, No.37), is amended to read:
- 11 Section 506. Eligibility. -- The department shall provide a
- 12 State blind pension to any blind person who:
- 13 (1) Resides in Pennsylvania;
- 14 (2) Is not an inmate of any penal institution or hospital
- 15 for mental disease;
- 16 (3) Has actual annual income of his own of [less] not more

- 1 than [four thousand two hundred sixty dollars (\$4,260)] the
- 2 Poverty Threshold by Family Size, for One Person, established by
- 3 the Bureau of the Census;
- 4 (4) Owns real or personal property of a combined value of
- 5 not more than seven thousand five hundred dollars (\$7500); and
- 6 who
- 7 (5) Has not disposed of any property without fair
- 8 consideration within the two years immediately preceding the
- 9 date of application for State blind pension, or while receiving
- 10 such pension, if ownership of such property, together with his
- 11 other property, would render him ineligible for such pension;
- 12 (6) Is not receiving supplemental security income for the
- 13 aged, blind and disabled pursuant to Title XVI of the Federal
- 14 Social Security Act.
- 15 With respect to the determination of eligibility for State
- 16 blind pension, the value of real property shall be deemed to be
- 17 its assessed value minus encumbrances but in no case shall the
- 18 assessed value be more than thirty percent of the official
- 19 market value; the value of personal property shall be deemed to
- 20 be its actual value; and interest in property owned by the
- 21 entireties shall be deemed to be a one-half interest.
- 22 Determination of the amount of an applicant's income and the
- 23 value of his property shall be made by the department without
- 24 regard to any Federal laws or regulations respecting income and
- 25 resources of applicants for aid to the blind. The valuation of
- 26 real property for the purposes of clause (4) shall not be
- 27 increased by reason of reassessment, except to the extent that
- 28 the real property has been actually enlarged or improved.
- 29 Determination of the amount of an applicant's income shall
- 30 exclude any increase in (i) social security payments to him

- 1 provided under Federal law and taking effect subsequent to
- 2 January 1, 1971; (ii) railroad retirement benefits provided to
- 3 him under the Railroad Retirement Act of [1937, 45 U.S.C. § 228
- 4 et seq., ] 1974 (Public Law 93-445, 45 U.S.C. § 231 et seq.), and
- 5 taking effect subsequent to January 1, 1976; and (iii) veterans'
- 6 benefits provided to him and administered by the Veterans'
- 7 Administration and taking effect subsequent to January 1, 1976.
- 8 Section 2. Section 507 of the act, amended April 6, 1980
- 9 (P.L.99, No.37), is amended to read:
- 10 Section 507. Amount of Pension.--Except as provided for
- 11 payment for nursing home care, the amount paid after the
- 12 effective date of this act to an eligible blind person having
- 13 actual annual income of his own [of three thousand sixty dollars
- 14 (\$3,060) or less] equal to the Poverty Threshold by Family Size,
- 15 for One Person, established by the Bureau of the Census, shall
- 16 be [one hundred dollars (\$100)] two hundred fifty dollars (\$250)
- 17 monthly[,]; and the monthly amount paid to any other eligible
- 18 blind person shall be fixed in such amount that the sum of his
- 19 actual annual income and State blind pension equals [four
- 20 thousand two hundred sixty dollars (\$4,260)] the Poverty
- 21 Threshold by Family Size, for One Person, established by the
- 22 <u>Bureau of the Census, plus one thousand two hundred dollars</u>
- 23 (\$1,200) a year.
- 24 Section 3. If this section takes effect after July 1, 2009,
- 25 the amendment of section 507 of the act shall apply
- 26 retroactively to July 1, 2009.
- 27 Section 4. This act shall take effect July 1, 2009, or
- 28 immediately, whichever is later.
