1 2	Recognizing the month of May 2009 as "Foster Care Month" in Pennsylvania.
3	WHEREAS, The family, a primary source of love, identity,
4	self-esteem and support, is the very foundation of our
5	communities and our Commonwealth; and
6	WHEREAS, In Pennsylvania there are 20,000 children and youth
7	in foster care every day; and
8	WHEREAS, Children and youth in foster care are provided a
9	safe, secure and stable home and a compassionate and nurturing
10	foster family; and
11	WHEREAS, Foster families open their homes and hearts to
12	children whose families are in crisis: and

WHEREAS, Foster families play a vital role in helping
 children and families heal and reconnect and in preparing
 children for successful adulthood; and

WHEREAS, Dedicated foster families frequently adopt foster
children, resulting in a greater need for more foster families;

7 WHEREAS, In this Commonwealth foster parents adopt more than 8 60% of the children in the child welfare system who have had 9 their goal changed to adoption; and

10 WHEREAS, Numerous individuals, public organizations and private organizations are working to increase awareness of the 11 12 needs of children in foster care or leaving foster care and of 13 the enduring and valuable contribution of foster parents; and 14 WHEREAS, The foster care system is only as good as those persons who choose to be part of it; therefore be it 15 16 RESOLVED, That the House of Representatives recognize the month of May 2009 as "Foster Care Month" in Pennsylvania and 17 18 urge all citizens to volunteer their talents and energies on 19 behalf of children in foster care, foster parents and child 20 welfare professionals.
