## A CONCURRENT RESOLUTION

- 1 Directing the Legislative Budget and Finance Committee to
- conduct a study of the Commonwealth's fragmented system of
- property tax reassessment, compare it to the property tax
- 4 reassessment system in Maryland, explore property tax systems
- of other states and identify ways to improve the system in
- 6 Pennsylvania, including the impact of adopting the Maryland
- 7 system.
- 8 RESOLVED (the Senate concurring), That the General Assembly,
- 9 in response to the 2006 Governance Committee Report,
- 10 Recommendations to Remove Barriers and Provide Incentives to
- 11 County and Local Governments for Improved Governance Options and
- 12 in response to the current economic hardship throughout the
- 13 Commonwealth of Pennsylvania, direct the Legislative Budget and
- 14 Finance Committee to conduct a study of the Commonwealth's
- 15 fragmented system of property tax reassessment; and be it
- 16 further
- 17 RESOLVED, That the Legislative Budget and Finance Committee
- 18 be charged with the following:

- 1 (1) Conduct a study of the current system of property 2 tax reassessment in Pennsylvania.
- 3 (2) Conduct a study of the current system of property 4 tax reassessment in Maryland.
- 5 (3) Conduct a study of other systems of property
  6 taxation implemented within other states with demographics
  7 similar to Pennsylvania.
- 8 (4) Conduct a study of the advantages and disadvantages 9 of adopting the Maryland system in this Commonwealth.
- 10 (5) Prepare a summary of the changes to Pennsylvania law
  11 that are necessary to adopt the Maryland system.
- 12 (6) Provide any other recommendations necessary or
  13 desirable to improve the system of property tax reassessment
  14 in Pennsylvania;
- 15 and be it further
- 16 RESOLVED, That the Legislative Budget and Finance Committee
- 17 report to the General Assembly the results of its studies and
- 18 its recommendations and file the report with the Secretary of
- 19 the Senate and the Chief Clerk of the House of Representatives
- 20 within six months of the adoption of this concurrent resolution.
