A RESOLUTION

- 1 Designating the month of January 2010 as "Financial Aid
- 2 Awareness Month" and commending the work of the Pennsylvania
- 3 Higher Education Assistance Agency and the Pennsylvania
- 4 Association of Student Financial Aid Administrators.
- 5 WHEREAS, January is the first month in which students can
- 6 apply for financial aid to help finance their postsecondary
- 7 education; and
- 8 WHEREAS, The ability of some college students to attend and
- 9 pursue a postsecondary education is conditional on the
- 10 availability of student financial assistance; and
- 11 WHEREAS, Knowledge of the availability of student financial
- 12 aid to help finance a postsecondary education has been shown to
- 13 vary across demographic groupings; and

- 1 WHEREAS, This Commonwealth, through the Pennsylvania Higher
- 2 Education Assistance Agency (PHEAA), has been one of the leading
- 3 states in the nation, providing need-based State grant financial
- 4 assistance to eligible Pennsylvania residents and providing
- 5 other State financial assistance programs; and
- 6 WHEREAS, The Pennsylvania Association of Student Financial
- 7 Aid Administrators (PASFAA) has been one of the leading State
- 8 associations of financial aid professionals in the nation who
- 9 advocate for access to postsecondary education and educate the
- 10 public on financial aid and funding opportunities; and
- 11 WHEREAS, The Free Application for Federal Student Aid (FAFSA)
- 12 is the first step in the financial aid process to apply for
- 13 Federal student aid, such as the Pell Grants, student loans and
- 14 college work-study programs; and
- 15 WHEREAS, FAFSA information is also used to award State grants
- 16 to Commonwealth students pursuing postsecondary education; and
- 17 WHEREAS, The Commonwealth, PHEAA and PASFAA want to promote
- 18 the availability of student financial assistance to help finance
- 19 a postsecondary education, in the form of Federal grants, State
- 20 grants, loans, work-study programs and other specialized State
- 21 funding programs to help eligible Pennsylvanians pursue their
- 22 postsecondary endeavors; therefore be it
- 23 RESOLVED, That the House of Representatives designate the
- 24 month of January 2010 as "Financial Aid Awareness Month," urge
- 25 all college students seeking financial assistance to apply for
- 26 financial aid through FAFSA and recognize the work of PHEAA and
- 27 PASFAA in their respective efforts to promote the availability
- 28 of postsecondary student financial assistance for the residents
- 29 of this Commonwealth.
