A RESOLUTION

- 1 Memorializing Congress to require the United States Department
- of Defense to issue identification cards to veterans of the
- 3 United States Armed Forces.
- 4 WHEREAS, Active duty and retired personnel of the United
- 5 States Armed Forces are issued official military identification
- 6 cards; and
- 7 WHEREAS, Service-connected disabled veterans of the United
- 8 States Armed Forces are considered VA compensable and are issued
- 9 United States Department of Veterans Affairs identification
- 10 cards for VA health care; and
- 11 WHEREAS, There is no identification card provided to
- 12 honorably discharged veterans of the United States Armed Forces
- 13 who are neither retired nor VA compensable; and
- 14 WHEREAS, These men and women of the armed forces served
- 15 honorably and defended the Constitution of the United States and
- 16 the freedoms and liberties of the citizens of this great nation;

- 2 WHEREAS, A proper United States Department of Defense Armed
- 3 Forces veteran's military identification card will enable these
- 4 heroic veterans and their survivors to verify their honored
- 5 service upon the request of public, private and governmental
- 6 entities; therefore be it
- 7 RESOLVED, That the Pennsylvania House of Representatives
- 8 memorialize the Congress of the United States to require the
- 9 United States Department of Defense to issue official
- 10 identification cards to all honorably discharged United States
- 11 Armed Forces veterans upon their release from active military
- 12 duty and upon request by veterans who are already honorably
- 13 discharged from active duty; and be it further
- 14 RESOLVED, That a copy of this resolution be transmitted to
- 15 the President of the United States, the presiding officers of
- 16 each house of Congress and to each member of Congress from
- 17 Pennsylvania.
