AN ACT

- Amending the act of June 3, 1937 (P.L.1333, No.320), entitled 1 "An act Concerning elections, including general, municipal, 2 special and primary elections, the nomination of candidates, primary and election expenses and election contests; creating and defining membership of county boards of elections; 5 imposing duties upon the Secretary of the Commonwealth, 6 courts, county boards of elections, county commissioners; imposing penalties for violation of the act, and codifying, 7 9 revising and consolidating the laws relating thereto; and repealing certain acts and parts of acts relating to 10 elections," in primary and election expenses, further 11 providing for registration; and providing for monthly 12 reporting and for manner of filing. 13 14 The General Assembly of the Commonwealth of Pennsylvania 15 hereby enacts as follows: 16 Section 1. Section 1624(b) of the act of June 3, 1937 17 (P.L.1333, No.320), known as the Pennsylvania Election Code, added October 4, 1978 (P.L.893, No.171), is amended to read: 19 Section 1624. Registration. --20 * * * 2.1 Each registration statement shall contain the following

- 1 (1) The name, addresses and phone numbers of the political
- 2 committee.
- 3 (2) The name, address and phone number of the committee's
- 4 treasurer.
- 5 (3) The name, address and phone number of the committee's
- 6 chairman.
- 7 (4) The names, addresses and relationships of other
- 8 affiliated or connected organizations.
- 9 (5) The candidates, if any, and their names and addresses.
- 10 (6) The ballot question, if any, which the committee intends
- 11 to support or oppose.
- 12 (7) The banks, safety deposit boxes or other repositories
- 13 and their addresses used by the committee.
- 14 (8) The proposed period of operation of the committee.
- 15 (9) The Internet website address if the Internet website is
- 16 <u>used to solicit and receive campaign contributions.</u>

- 18 Section 2. The act is amended by adding sections to read:
- 19 <u>Section 1626.2. Monthly Reporting.--Any political committee</u>
- 20 or candidate who receives contributions in an aggregate amount
- 21 of fifty thousand dollars (\$50,000) in a calendar month or
- 22 incurs expenditures of fifty thousand dollars (\$50,000) in a
- 23 calendar month shall file a report within thirty (30) days of
- 24 the last day of that month with the Secretary of the
- 25 Commonwealth.
- 26 Section 1631.1. Manner of Filing.--
- 27 <u>All Statewide candidates and candidates for Senator or</u>
- 28 Representative in the General Assembly shall file all their
- 29 reports electronically with the Secretary of the Commonwealth.
- 30 Section 3. This act shall take effect in 60 days.
