AN ACT

Amending the act of September 30, 1983 (P.L.160, No.39), entitled "An act establishing salaries and compensation of 2 certain public officials including justices and judges of 3 Statewide courts, judges of courts of common pleas, judges of the Philadelphia Municipal Court, judges of the Philadelphia Traffic Court, district justices and the Governor, the Lieutenant Governor, the State Treasurer, the Auditor 7 General, the Attorney General and certain other State 8 officers and the salary and certain expenses of the members 9 10 of the General Assembly; and repealing certain inconsistent acts," further providing for compensation of the Liquor 11 12 Control Board. 13 The General Assembly of the Commonwealth of Pennsylvania 14 hereby enacts as follows: 15 Section 1. Section 3(b.1) of the act of September 30, 1983 16 (P.L.160, No.39), known as the Public Official Compensation Law, amended October 19, 1995 (P.L.324, No.51), is amended to read: 17 18 Section 3. Compensation of Governor and Lieutenant Governor; 19 State Treasurer; Auditor General; Attorney General; 20 Commissioners of the Pennsylvania Public Utility 21 Commission; and heads of departments. 22

- 11 of the Athletic Commission, \$12,500; Chairman of the Athletic
- 12 Commission, \$13,125; member of the Board of Pardons, \$11,500;
