A SUPPLEMENT

- 1 To the act of April 1, 1863 (P.L.213, No.227), entitled "An act
- to accept the grant of Public Lands, by the United States, to
- the several states, for the endowment of Agricultural
- 4 Colleges, " making appropriations for carrying the same into
- effect; and providing for a basis for payments of such
- appropriations, for a method of accounting for the funds
- appropriated and for certain fiscal information disclosure.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- 9 hereby enacts as follows:
- 10 Section 1. (a) In order to carry into effect the act of
- 11 Congress, approved July 2, 1862, granting public land to the
- 12 several states for educational purposes, and subsequent acts of
- 13 Congress related thereto, and the act of the General Assembly of
- 14 Pennsylvania accepting the provisions and conditions of said
- 15 acts of Congress and pledging the faith of the State to carry
- 16 the same into effect, the following sums, or as much thereof as
- 17 may be necessary, are hereby appropriated to the Trustees of The
- 18 Pennsylvania State University for the fiscal year July 1, 2009,
- 19 to June 30, 2010, for the purposes and in the amounts as shown:
- For general support.

5	(b) The following Federal amounts are hereby appropriated to
6	the Trustees of The Pennsylvania State University in order to
7	supplement the sums appropriated under subsection (a):

15	(c) The following Federal amounts, or as much thereof as may
16	be necessary, are hereby appropriated to the Trustees of The
17	Pennsylvania State University for the fiscal year July 1, 2008,
18	to June 30, 2009, for the purposes and in the amounts as shown,
19	including the payment of bills remaining unpaid at the close of
20	the fiscal year ending June 30, 2009:
21	(1) "ARRA - FISCAL STABILIZATION - General Support."

28	(d) For purposes of this section, "ARRA" means the American
29	Recovery and Reinvestment Act of 2009 (Public Law 111-5, 123
30	Stat. 115).

- 1 Section 2. Payments to The Pennsylvania State University on
- 2 account of the appropriations for all items as provided in
- 3 section 1 shall be made on the basis of costs during the fiscal
- 4 year.
- 5 Section 3. (a) Payments to The Pennsylvania State
- 6 University of the appropriations provided in section 1(a) and
- 7 (b) shall be made monthly during the fiscal year and the
- 8 appropriation provided in section 1(c) shall be made no later
- 9 than September 15, 2009 30 DAYS FROM THE COMMONWEALTH'S RECEIPT
- 10 OF FUNDS UNDER THE ARRA STATE FISCAL STABILIZATION FUND PROGRAM.
- 11 (b) Such monthly payments shall be made in accordance with
- 12 the provisions of section 2 on the basis of estimated costs. The
- 13 estimate of costs shall be submitted by The Pennsylvania State
- 14 University to the Secretary of Education, the General Assembly
- 15 and the State Treasurer not later than 30 days prior to the date
- 16 on which such payment is to be made.
- 17 Section 4. (a) The Pennsylvania State University shall
- 18 apply the moneys appropriated by this act only for such purposes
- 19 as are permitted in this act and shall at all times maintain
- 20 proper records showing the application of such moneys. Not later
- 21 than 120 days after June 30, 2010, The Pennsylvania State
- 22 University shall file, with the Secretary of Education, the
- 23 General Assembly and the Auditor General of the Commonwealth, a
- 24 statement setting forth the amounts and purposes of all
- 25 expenditures made from moneys appropriated by this act and other
- 26 university accounts during said fiscal year, as provided in
- 27 section 2, used as a basis for receipt of any appropriation
- 28 during said fiscal year.
- 29 (b) Such statement of expenditures and costs shall be
- 30 reviewed by the Auditor General of the Commonwealth, and he

- 1 shall have the right, in respect to the moneys appropriated by
- 2 this act, to audit and disallow expenditures made for purposes
- 3 not permitted by this act and to cause such sums to be recovered
- 4 and paid by The Pennsylvania State University to the State
- 5 Treasurer. In respect to expenditures made by the university
- 6 from moneys other than those appropriated by this act, the
- 7 Auditor General shall have the right to review only, and he
- 8 shall file annually with the General Assembly such information
- 9 concerning such expenditures as the General Assembly or any of
- 10 its committees may require.
- 11 Section 5. The Pennsylvania State University shall provide
- 12 full, complete and accurate information as may be required by
- 13 the Department of Education or the chairman or the minority
- 14 chairman of the Appropriations Committee of the Senate or the
- 15 chairman or the minority chairman of the Appropriations
- 16 Committee of the House of Representatives.
- 17 Section 6. The Pennsylvania State University shall present
- 18 and report its financial statements required under the
- 19 provisions of this act in accordance with: the generally
- 20 accepted accounting principles as prescribed by the National
- 21 Association of College and University Business Officers, the
- 22 American Institute of Certified Public Accountants, or their
- 23 successors, or by any other recognized authoritative body; the
- 24 "Commonwealth of Pennsylvania Budget Instructions for the State
- 25 System of Higher Education, State-Related Universities and Non-
- 26 State-Related Colleges and Universities"; and, the financial
- 27 reporting policies and standards promulgated by the Commonwealth
- 28 of Pennsylvania and by the Federal Government that apply to The
- 29 Pennsylvania State University.
- 30 Section 7. The Pennsylvania State University shall make all-

- 1 articulation agreements with other higher education institutions
- 2 available on the Internet.
- 3 Section $\frac{8}{7}$. This act shall take effect immediately.
