AN ACT

Amending the act of November 29, 2006 (P.L.1456, No.160), entitled "An act limiting the collection of Social Security 2 numbers on State and local government forms; prohibiting 3 health insurers from using Social Security numbers; and 5 providing for duties of the Department of Transportation," further providing for use of Social Security numbers 6 alternatives. The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows: 10 Section 1. Section 3(c) of the act of November 29, 2006 11 (P.L.1456, No.160), known as the Social Security Number Privacy Act, is amended and the section is amended by adding a 13 subsection to read: 14 Section 3. Use of Social Security numbers alternatives. * * * 15 16 (c) Licensing agencies and municipalities. -- Except as 17 provided in subsection (d), Commonwealth agencies and 18 municipalities issuing or renewing a professional license or 19 certification, occupational license or certification or 20 recreational license and collecting the individual's SSN for the

- 2 develop application and renewal forms containing all of the
- 3 following:
- 4 (1) Space for the individual's department-issued
- 5 driver's license number as an alternative to the individual's
- 6 SSN.
- 7 (2) Space for the individual's department-issued
- 8 nondriver identification card number as an alternative to the
- 9 individual's SSN.
- 10 (3) A statement to read as follows:
- 11 By affixing my driver's license number or nondriver's
- 12 identification number issued by the Pennsylvania
- Department of Transportation, I authorize the
- 14 Pennsylvania Department of Transportation to release my
- Social Security number to (insert Commonwealth agency or
- 16 municipality) for the limited purpose of complying with
- 17 23 Pa.C.S. § 4304.1(a)(2).
- 18 <u>(d) Electronic issuance or renewal.--When a Commonwealth</u>
- 19 agency or municipality electronically issues or renews a
- 20 professional license or certification, occupational license or
- 21 certification or recreational license, application and renewal
- 22 forms shall not be required and the Commonwealth agency or
- 23 municipality shall be permitted to collect electronically an
- 24 individual's department-issued driver's license number or
- 25 nondriver identification card number as an alternative to the
- 26 individual's SSN. Any individual who electronically provides a
- 27 department-issued driver's license number or nondriver
- 28 identification card number to a Commonwealth agency or
- 29 municipality as an alternative to the individual's SSN shall be
- 30 deemed to have given consent to the department to release the

- 1 <u>individual's SSN to the Commonwealth agency or municipality for</u>
- 2 the limited purpose of complying with 23 Pa.C.S. § 4304.1(a)(2).
- 3 Section 2. This act shall take effect in 60 days.
